Procedure of Online Common Entrance Test for Admissions to Postgraduate Courses in Physiotherapy [M.P.Th], Occupational Therapy [M.O.Th], Speech Language Pathology (M.Sc SLP) / Audiology [M.Sc (Aud)] & Prosthetics and Orthotics [M.Sc (P & O)].

1. INTRODUCTION

1.1 The Government of Maharashtra has established "ADMISSIONS REGULATING AUTHORITY AND STATE COMMON ENTRANCE TEST CELL" as per the provisions of Maharashtra unaided private professional Educational Institutes (Regulation of Admission & Fees) Act.2015, (herein after the act). As per the act, the State Government has published the rules in Maharashtra Government Gazette No.CET 3516/C.R.311/16/Edu-2, Dated 18/04/2017 **(Annexure-F).**

The Commissioner of State CET Cell, has been designated as Competent Authority for conducting PGP-CET 2021/PGO-CET 2021/ M.Sc (SLP) /M.Sc (Aud) -CET 2021 & M.Sc (P&O) - CET 2021 and selection of candidates for admission to all concerned postgraduate courses for the year 2020-2021.

As per this act, PGP-CET 2021/PGO-CET 2021/ M.Sc (SLP) /M.Sc (Aud)-CET 2021 & M.Sc (P&O) - CET 2021 is applicable for postgraduate admissions to Private Unaided Physiotherapy [M.P.Th], Occupational Therapy [M.O.Th], Speech Language Pathology (M.Sc SLP) / Audiology [M.Sc (Aud)] & Prosthetics & Orthotics [M.Sc (P & O)] Colleges/ Institutions. The Government of Maharashtra has decided to join this process for admission to Postgraduate courses in Physiotherapy [M.P.Th], Occupational Therapy [M.O.Th], Speech Language Pathology (M.Sc SLP) / Audiology [M.Sc (Aud)] & Prosthetics & Orthotics [M.Sc (P & O)] at Government & Municipal Corporation Colleges / Institutions as per Government Resolution MED/1015/C.R396/15/ Edu-2, dated 16 December 2015. **(Annexure - G).**

1.2 This procedure will be called as "Procedure for selection and admission to postgraduate courses at the State Government Colleges / Brihanmumbai Municipal Corporation Colleges / Central Govt. Institutes situated in Maharashtra and all other unaided Private Institutes who opt. for admission to aforesaid PG Courses through CET 2021.

1.3 This procedure is applicable for PGP-CET /PGO-CET / M.Sc (SLP) /M.Sc (Aud) - CET & M.Sc (P&O) - CET for admissions of the year 2021-2022. No promise is implied therein for subsequent years and no expectations should be based on this procedure for future.

1.4 The Brochure for PGP-CET 2021/PGO-CET 2021/ M.Sc (SLP) /M.Sc (Aud) -CET 2021 & M.Sc (P&O) - CET 2021 contains detail procedures of online application form, document verification, Online preference form filling and selection process for online entrance examination for admission to various Postgraduate courses in

Physiotherapy [M.P.Th], Occupational Therapy [M.O.Th], Speech Language Pathology (M.Sc SLP) / Audiology [M.Sc (Aud)] & Prosthetics & Orthotics [M.Sc (P & O)].

1.5 The Government of Maharashtra vide Letter No. MED-1021/C.R.285/21/Edu-2, dated 20/12/2021.has given approval to Information Brochure 2021 for academic year 2021-22.

(Annexure – H)

1.6 The desirous eligible candidates should frequently visit the site of State CET CELL www.mahacet.org for latest update of rules and information published by Government / MUHS, Nashik / Hon'ble courts from time to time.

1.7 Instructions in this information brochure regarding admission process are liable to change based on any order / Instruction / rules / directions by Respective Council / Central Government / State Government / Hon'ble Supreme Court and Hon'ble High Court from time to time

2. DEFINATIONS of important terms are given in **Annexure "A"**.

3. COMPETENT AUTHORITY:

The Commissioner of STATE CET CELL has been declared as the Competent Authority as per the provisions of 2(e) and section 10(2) of the act. Therefore as per provisions of act, the Commissioner STATE CET CELL will conduct the Common Entrance Test 2021-2022 and will prepare the merit of PGP-CET 2021/PGO-CET 2021/ M.Sc (SLP) /M.Sc (Aud) -CET 2021 & M.Sc (P&O) - CET 2021. The Competent Authority will supervise and control the selection process by implementing these procedures through the CET CELL.

The Competent Authority will issue necessary executive instructions for implementation of these procedures and provide relevant information to be published or communicated. The Competent Authority will declare time-table, details of the dates of various processes relating to selection procedure, e.g. online filling of application forms, date of entrance exam, date of counseling etc.

4. LIST OF INSTITUTIONS CONDUCTING POSTGRADUATE COURSES:

The list of institutions conducting postgraduate Degree courses is given in Annexure "B".

5. DISTRIBUTION OF PG SEATS FROM GOVERNMENT/ CORPORATION / GOVERNMENT AIDED COLLEGES / UNAIDED PRIVATE AND MINORITY COLLEGES.

5.1 The seats available for admission to postgraduate courses through PGP-CET / PGO-CET / M.Sc (SLP) /M.Sc (Aud) -CET / M.Sc (P&O)-CET will be from Maharashtra State Government Colleges, Brihanmumbai Municipal Corporation (BMC) Colleges, Central Govt. Institutes situated in Maharashtra and all other Private Institutes who opt. for admission to aforesaid PG Courses through CET 2021.

- 5.2 The institute wise availability and distribution of seats will be displayed on the website of State CET CELL (www.mahacet.org) in due course.
- 5.3 Seats left unfilled in an academic year, shall not be carried forward to the next or subsequent academic years. Cut off date of admission for the PG courses is 31st March 2022.
- 5.4 The seats available will be filled in on the basis of State Level Merit in PGP-CET / PGO-CET / M.Sc (SLP) /M.Sc (Aud)-CET / M.Sc (P&O)-CET. There will be no regional reservation. There will be reservation as per Government orders issued from time to time (Annexure "C" & "D").
- 5.5 The candidates desirous of claiming the reservation must have claimed the same in the original application form of PGP-CET 2021 / PGO-CET 2021 / M.Sc (SLP) /M.Sc (Aud) -CET 2021 / M.Sc (P&O)-CET-2021 failing which the claim will not be entertained subsequently.
- 5.6 The Distribution of seats at the disposal of Competent Authority will be made by taking into consideration the reservations as listed in Annexure "C" & Annexure "D". **The reservation under Orphan Category shall be filled as per provisions in Government Letter no. MED-1018/C.R. 201/18/Edu-2, dated 20 June, 2018. Annexure "I".**
- 5.7 A candidates belonging to backward classes from Maharashtra State only are eligible for claiming seat under reserved category.
- 5.8 Rule and orders issued by Hon'ble Courts, Central Government, State Government, Respective councils, MUHS, Nashik from time to time will be applicable to this admission process.
- 6. ELIGIBILITY CRITERIA FOR PGP-CET-2021 / PGO-CET-2021 / M.Sc (SLP) /M.Sc (Aud) -CET -2021 / M.Sc (P&O)-CET- 2021 FOR POSTGRADUATE COURSES:**
- 6.1 Candidate must be an **Indian National**. Nationality Certificate issued by District Magistrate or Additional District Magistrate or Chief Metropolitan Magistrate or valid passport or School Leaving Certificate of HSC/12th Std. indicating the nationality of the candidate as "Indian" shall constitute the proof of nationality.
Non Resident Indians (NRI) are eligible only for maximum 15% NRI Quota seats in the Unaided Private/Minority colleges.
Non Resident Indians (NRI) are not eligible for any other seat except NRI quota seats in unaided private and Private Minority colleges, subject to fulfillment of NRI status.
Persons of Indian Origin (PIO) / Overseas Citizen of India (OCI) are Not eligible for any seat under Competent Authority, State CET Cell.
- 6.2 A candidate, who has passed **A)** final B.P.Th./ B.O.Th. examination (recognized as per Maharashtra State Council for Occupational Therapy and Physiotherapy

- Act 2002): **B)** Final BASLP/BPO examination (recognized As per The Rehabilitation Council of India Act 1992); **from an college/institution situated in the State of Maharashtra** is eligible to appear for this examination provided he/she has completed prescribed duration of compulsory rotating internship by 30th November 2021.
- 6.3 A candidate who is undergoing rotating internship and who is likely to complete the same by 30th November 2021 can appear for PGP-CET2021/PGO-CET2021/ M.Sc (SLP) /M.Sc (Aud) -CET 2021 & M.Sc.(P&O)-CET 2021. Such a candidate will have to submit the documentary proof, from the Principal / Dean of the college regarding the date of completion of internship at the time of Document Verification process. **(Annexure “J”)**
- 6.4 The candidate must be medically fit.
- 6.5 All Candidates desirous to take admission for MPTTh/ MOTH/ MSc (SLP)/MSc (Aud) & MSc. (P&O) courses under state quota or Institutional quota must have appeared for PGP-CET2021/PGO-CET2021/ M.Sc (SLP) /M.Sc (Aud) -CET 2021 & M.Sc.(P&O)-CET 2021 and declared eligible by the Competent Authority.
- 6.6 **Candidates belonging to Backward Classes must have claimed so in his online registration form of Maharashtra State, failing which such a claim will not be entertained subsequently.** The candidate belonging to above **Categories** should produce **Caste Certificate, Caste Validity Certificate and Non-Creamy Layer Certificate, (wherever applicable)** at the time of physical document verification process. Candidate who fails to produce above said certificates will be considered as **Open Category Candidate** provided he/she fulfills the eligibility criteria of Open candidate as per PGP-CET2021/PGO-CET2021/ M.Sc (SLP) /M.Sc (Aud) -CET 2021 & M.Sc.(P&O)-CET 2021 information brochure.
- 6.7 **EWS CATEGORY RESERVATION:** -10% seats of the available seats in Government / Corporation / Unaided private institutes shall be reserved for candidate belonging to EWS category (If made applicable). This reservation is subject to Hon'ble Supreme Courts / High Courts decision in W.P (c) No. 961/2021 and related petitions.
- 6.8 A Reserve category candidate must claim his category at the time of registration; to claim such a category no document is required initially. A candidate belonging to a category but not having any physical document can also claim category reservation during registration process; however he/she must produce the said certificates at the time of document uploading / physical document verification process so as to avail respective category claim.

- 6.9 **A Candidate belonging to ‘Creamy Layer’ amongst the categories (VJ) DT -A, NT-B, NT-C, NT-D, OBC and SBC must note that the provision of reservation is NOT applicable to him / her. A candidate claiming benefit of reservation under these categories will be required to produce Non-Creamy Layer Certificate as specified in the Government Resolutions form time to time. The certificate in prescribed Proforma stating that it is valid up to 31/3/2021 should be submitted at the time of document uploading / physical document verification process.**
- 6.10 EWS candidates should produce eligibility certificate in prescribed format issued by appropriate authority for academic year 2021-22 at the time of Document uploading / physical document verification process. (**Annexure “N”**) (If made applicable). This reservation is subject to Hon’ble Supreme Courts / High Courts decision in W.P (c) No. 961/2021 and related petitions.
- 6.11 The available post graduate seats for admission to the concern stream will be distributed in accordance to constitutional reservation policy of State of Maharashtra as mentioned in **Annexure "C"**. The specified reservation under Person's With Disability (PWD) category shall be filled as mentioned in **Annexure "D"**. The reservation under Orphan Category shall be filled as per provisions in Government Letter no. MED-1018/C.R. 201/18/Edu-2, dated 20 June, 2018. **Annexure "I"**
- 6.12 In view of Hon’ble Supreme Court order Dated 06.09.2017 in CA 11234-48 of 2017, it is mandatory to submit cast validity certificate.
- 6.13 The candidate has to fulfill qualifications and eligibility criteria as mentioned in rules published by Government from time to time.
- 6.14 The candidate admitted for the graduate course on the basis of Court order for Caste claim is required to submit Caste Validity Certificate given by the Caste Scrutiny Committee or a fresh court order, failing which the claim will not be granted and the candidate will be considered as an Open category candidate.
- 6.15 **Non-eligibility of Candidates:** The following candidates will not be eligible for applying / appearing at PGP-CET2021/PGO-CET2021/ M.Sc (SLP) /M.Sc (Aud) - CET 2021 & M.Sc (P&O)-CET 2021 admission:
- 6.15.1 Candidates who have passed Final year B.P.Th./ B.O.Th./ M.Sc (Aud.)/M.Sc (SLP) /BPO exam from **institute located outside Maharashtra.**
- 6.15.2 Candidates who have passed Final year B.P.Th./ B.O.Th./ M.Sc (SLP)/ M.Sc (Aud.) /BPO exam from institute not recognized by respective Council.

- 6.15.3 Candidates who are not completing internship on or before 30th November 2021.
- 6.15.4 NRI candidates are not eligible for seats in Government/Corporation Colleges, State quota of Central Government colleges/Government aided colleges/State CET Cell quota seats of Unaided Private and Minority colleges.**
- 6.15.5 PIO/OCI/ foreign national candidates are not eligible for any quota seats in the State of Maharashtra.**
- 6.15.6 Candidates who have not appeared for PGP-CET2021/PGO-CET2021/ M.Sc (SLP) /M.Sc (Aud)-CET 2021 & M.Sc (P&O)-CET 2021 conducted by Competent Authority, State CET CELL, Maharashtra State.**
- 6.15.7 Candidates who were admitted and subsequently resigned/left a postgraduate seat after the Prescribed date resulting in lapse of seat in the admission process of 2020.
- 6.16 Candidate who are previously registered and are pursuing / have completed the PG degree course or have obtained PG degree. This prohibition will apply to Post Graduate admission in Government/ Corporation run College only. Such candidate can be considered for admission at Private Unaided College.
- 6.17 PERSON WITH DISABILITY (PWD) QUOTA:**
- 6.15.1 As per Medical Council of India, New Delhi amendment notification No: No. No.MCI-18(1)/2018-Med./187262.dated 13th March, 2019, Five (5%) seats of annual sanctioned intake capacity shall be filled up by candidates with specified benchmark disabilities contained in the schedule to the Rights of Persons with Disabilities Act, 2016. The guidelines for admission of persons with Specified Disabilities published by Medical Council of India, New Delhi regarding PWD eligibility from time to time will be applicable (Annexure – D).
- The specified disability categories as mentioned in the rights of persons with Disability Act 2016 are as follows.
1. Physical disability
 2. Intellectual disability
 3. Mental behavior disability
 4. Disability caused due to chronic illness
 5. Multiple disabilities
- 6.15.2 Candidate should mark as PWD in the online application form, failing which claim will not be granted. Candidate is required to submit the proof of his/her disability by way of a certificate issued by certificate issuing authority in the year 2021 at the time uploading of document and physical verification of documents.

6.15.3 **Instructions to Person with Disability Candidates:** All qualified persons with Disability PWD (PH) Category Candidates of PGP/PGO/ M.Sc (SLP) /M.Sc (Aud)/ MSc (P&O) CET 2021 are advised to get themselves examined at following Medical Board in the State of Maharashtra to obtain Disability PWD (PH) Certificate in advance. Candidates, who have attended any one of these Medical Board, should submit / upload the disability certificate as per the prescribed format during online uploading of certificates:

1. All India Institute of Physical Medicine and Rehabilitation, Mumbai or
2. Grant Government Medical College, J.J. Hospital Compound, Byculla, Mumbai.

Candidate shall produce the same disability certificate at the time of physical document verification process. It is mandatory to bring disability certificate issued by anyone institution. Candidate without disability certificate will be considered as Non PWD candidate.

7. INFORMATION BROCHURE AND ONLINE APPLICATION FORM

7.1 The Competent Authority shall issue Notice regarding online application form process. The information Brochure containing procedures for Online Common Entrance Test for admission to MPTh, MOTh, M.Sc (SLP) /M.Sc (Aud) & MSc. (P&O) Postgraduate courses in State of Maharashtra will be made **available on website www.mahacet.org** An applicant seeking admission through PGP-CET2021/PGO-CET2021/ M.Sc (SLP) /M.Sc (Aud)-CET 2021 & M.Sc.(P&O)-CET 2021. Will be required to submit **single prescribed online application form (ANNEXURE "E" Specimen Copy of online application form).**

7.2 Cost of online application form of PGP-CET2021/PGO-CET2021/ M.Sc (SLP) /M.Sc (Aud)-CET 2021 & M.Sc.(P&O)-CET 2021 & Examination fee is **Rs. 2000/-**. **This amount is not refundable.**

7.3 PGP-CET2021/PGO-CET2021/M.Sc(SLP)/M.Sc(Aud)-CET2021&M.Sc.(P&O)-CET 2021 will be conducted online at **Mumbai, Pune, Nagpur and Aurangabad only.**

7.4 The Information Brochure and online registration Form will be available between prescribed date as per Notice on **<http://cetcell.mahacet.org/>**. Before filling Online Application form candidates should download information brochure of **PGP-CET2021/PGO-CET2021/ M.Sc (SLP) /M.Sc (Aud) -CET 2021 & M.Sc (P&O)-CET 2021** and read the same carefully. The Applicants must possess the required criteria and educational qualification as mentioned in the Information Brochure of PGP-CET2021/PGO-CET2021/ M.Sc (SLP) /M.Sc (Aud)-CET 2021 & M.Sc.(P&O)-CET 2021.

7.5 Before submission of Application Form the candidate should read carefully the conditions given under "**Declaration by the Candidate**" Candidate should agree to the below given conditions, before submitting the application form.

"Declaration by the Candidate"

- i) I hereby solemnly and sincerely affirm that each and every statement made and the entire information given by me in the application form is true and correct.
- ii) I have not concealed any material information, however if any information submitted herein is found fraudulent, incorrect or untrue, I understand that I am liable to criminal persecution and I also agree to forgo my seat in Medical Postgraduate course. I also understand that my selection and admission to the course is also liable to be cancelled.
- iii) I have carefully read the rules & regulations of PGP/PGO/ M.Sc (SLP) /M.Sc (Aud)/MSc (P&O) CET 2021 brochure and I agree to abide by them. Hereby accept in entire the legality, validity and correctness of these rules. - iv) I undertake to submit all the required original certificates at the time of uploading of document / physical Document verification process as well as at the time of admission to a course/college as per the rules, failing which I understand that my claim for selection shall not be granted.

If candidates agreed for aforesaid conditions then only he should click the "I Agree" Button so that his application form will be accepted.

7.6 The details of Online Application / Registration Procedure & Process of Online submission of application form are given in Annexure -E. Applicants should follow these procedure/guidelines at the time of filling online application form.

Admit Card:

7.7 DOWNLOAD OF ADMIT CARD: Candidates will have to visit the www.mahacet.org Website for downloading admit cards for online test. Intimation for downloading admit card will also be sent through email/SMS.

Once the candidate clicks the relevant link, he/she can access the window for admit card download. The candidate is required to use

- (i) Registration Number
- (ii) Password/Date of Birth for downloading the admit card.

Candidate needs to affix recent recognizable photograph on the admit card preferably the same as provided during registration and appear at the examination centre with

- (i) Admit card
- (ii) Photo Identity Proof

- 7.8** The Admit Cards will be downloaded from <http://cetcell.mahacet.org/> website after login **as per prescribed date declared in Notice.**
- 7.9** Candidate has to go to the Examination Centre with downloaded Admit Card and **any original** Photo ID proof as given in the admit card (Aadhar Card/ Driving license/ PAN Card/ Pass port)
- 7.10** Issue of Admit Card is merely an enabling document for appearing at the PGP-CET2021/PGO-CET2021/ M.Sc (SLP) /M.Sc (Aud)-CET 2021 & M.Sc.(P&O)-CET 2021 And does not imply that the candidate satisfies all the requirements of eligibility conditions of admission.
- 7.11** CANDIDATES REPORTING LATE i.e. after the reporting time specified on the admit card for Examination candidate will not be permitted to take the examination. The reporting time mentioned on the admit card is prior to the Start time of the test. Though the duration of the examination is 1.30 hours, candidates may be required to be at the venue for about 3 hours including the time required for completion of various formalities such as verification and collection of various requisite documents, logging in, giving of instructions.

7.12 IDENTITY VERIFICATION

In the examination hall admit card along with original and a photocopy of the candidate's currently valid photo identity (bearing exactly the same name as it appears on the admit card) such as PAN Card/ Passport/ Driving License/ Voter's Card/ valid recent Identity Card issued by a recognized College/ University/ Aadhar/E Aadhar card with a photograph/ Employee ID with photograph should be submitted/shown to the invigilator for verification. The syllabus for Common Entrance Test shall be same as prescribed by Maharashtra University of Health Science, Nashik and Shall cover all the subjects of respective undergraduate course. - 8.4 No candidate will be allowed to appear for the examination unless he/she holds downloaded an Admit Card and Photo ID proof as mentioned above.
- 8.5 The Entrance Examination will be Online conducted on the prescribed date to be declared through Notice.
- 8.6 The candidate will follow the instructions given at the On-line examination centre.


8.7 Details about On-line Test Pattern :

- 8.7.1 A login screen will be displayed to the candidate. The candidate has to log in using Login ID, Roll No. and Password.
- 8.7.2 Exam name, duration will be displayed and the Candidate has to Click 'Proceed' Button.
- 8.7.3 The candidate's profile (name, roll no. etc.) will be displayed and the candidate has to click 'confirm' Button after selecting 'I Agree' Checkbox if the profile is correct. Thereafter the instructions will be displayed on the screen. The candidate should ensure that the profile displayed on the screen is that of himself / herself. In case of any discrepancy, the same may be brought to the notice of the Test Administrator/Invigilator prior to the start of examination.**
- 8.7.4 A candidate should read the instructions carefully and indicate that he has done so by 'checking' the box at the bottom of the screen, after which the 'I am ready to begin' button is activated.
- 8.7.5 After clicking on the 'I am ready to begin' button, the actual test time will begin.
- 8.7.6 Each question is followed by 4 **alternatives/options**.
- 8.7.7 The questions will be available in **English**.
- 8.7.8 Only one question will be displayed at a time.
- 8.7.9 The clock has been set at the server and the countdown timer at the top right corner of the screen will display the time remaining to complete the exam. When the clock runs out the exam ends by default-the candidate is not required to end or submit his exam.
- 8.7.10 The question palette at the right of the screen shows one of the following statuses of each of the questions numbered:

 Attempted & Reviewed

 Not Attempted & Reviewed

The Marked for Review status simply acts as a reminder that the candidate has set to look at the question again. If an answer is selected for a question that is Marked for Review, the answer will be considered in the final evaluation.

- 8.7.11 To select a question to answer, the candidate can do one of the following:
- (a) Click on the question number on the question palette at the right of the screen to go to that numbered question directly. Note that using this option does NOT save the answer to the current question.
 - (b) Click on 'Save and Next' to save answer to current question and to go to the next question in sequence.
- 8.7.12 To select the answer, click on one of the option buttons.
- 8.7.13 To change the answer, click another desired option button.
- 8.7.14 To save the answer, the candidate MUST click on 'Save & Next'.
- 8.7.15 To mark a question for review, select 'Mark for Review' checkbox and click 'Save and Next'. If an answer is selected for a question that is 'Marked for Review', the answer will be considered in the final evaluation.
- 8.7.16 To change an answer to a question, first select the question and then click on the new answer option followed by a click on the 'Save and Next' button.
- 8.7.17 Questions that are saved or marked for review after answering will ONLY be considered for evaluation.
- 8.7.18 Under no circumstances should a candidate click on any of the 'keyboard keys' once the exam starts as this will lock the exam.
- 8.7.19 A candidate can only change his/ her answer before clicking the 'Submit' button.
- 8.7.20 After the expiry of the exam duration, candidates will not be able to attempt any question or check their answers. A candidate's answers would be automatically saved by the computer system even if he has not clicked the 'Submit' button.

8.8 Instruction regarding online examination

- 8.8.1 The possibility of occurrence of some problem in the administration of the examination cannot be ruled out completely which may impact test delivery and/or result from being generated. In that event, every effort will be made to rectify such problem, which may include movement of candidates, delay in test. Conduct of a re-exam is at the absolute discretion of test conducting body. Candidates will not have any claim for a re-test. Candidates not willing to move or not willing to participate in the delayed process of test delivery shall be summarily rejected from the process.
- 8.8.2 Decision of State common entrance test cell, Mumbai in all matters relating to examination will be final and binding on the candidate.

- 8.8.3 State common entrance test cell, Mumbai would be analyzing the responses (answers) of individual candidates with those of other candidates to detect patterns of similarity of right and wrong answers. If in the analytical procedure adopted State common entrance test cell, Mumbai in this regard, it is inferred/ concluded that the responses have been shared and scores obtained are not genuine/ valid, State common entrance test cell, Mumbai reserves right to cancel the candidature of the concerned candidates and the result of such candidates (disqualified) will be withheld.
- 8.8.4 Instances for providing incorrect information and/or process violation by a candidate detected at any stage of the examination process will lead to disqualification of the candidate from the examination process and he/she will not be allowed to appear examination process in the future.
- 8.8.5 All eligible candidates are required to take PGP-CET2021/PGO-CET2021/ M.Sc(SLP)/M.Sc(Aud)-CET2021 & M.Sc.(P&O)-CET 2021 at their own cost.
- 8.8.6 Question paper will be made available Online and Model Answer keys will be made available Online at website <http://cetcell.mahacet.org/> on prescribed date as mentioned in Notice.
- 8.8.7 Online submission of objections against any question in the question paper/ answer key of this online examination if any, the same may be submitted through website <http://cetcell.mahacet.org/> within the prescribed time period as mentioned in Notice. Representation received after this period shall not be considered.

9. DECLARATION OF PROVISIONAL RESULT/MARKS :

- 9.1 The Competent Authority shall conduct the PG Entrance Examination, evaluate the answer-sheets and prepare the Provisional results/Mark.
- 9.2 The Competent Authority shall declare the provisional result/marks scored by candidates of PGP-CET / PGO-CET / M.Sc (SLP) /M.Sc (Aud)-CET / M.Sc (P&O)-CET on prescribed date as mentioned in Notice at website <http://cetcell.mahacet.org/>. The candidates should download the copy of provisional result/marks by login at website.
- 9.3 In case of any typographical error in result/Mark, regarding name, age, gender, category etc. it will be corrected at the time of physical document verification at allotted college.
- 9.4 Provisional State Merit will be declared on prescribed date as mentioned in Notice at Website of State CET CELL The Candidates will have to download statement of mark from the website of State CET CELL. The downloadable mark sheet will be made available till the last date of online preference form filling process.

Once document are submitted online, it will be e-verified. If all the relevant documents are correct and complete, it will be informed to each candidate. As per the deficiency of document via email and SMS on the registered email id and mobile.

The deficient documents will be notified via email and SMS on their registered email id.

11. For Constitutional reservation category candidates: Ear-Marking - Reserved category candidate entitled to admission on the basis of merit in an open category seat will have the option of taking admission either against his/her respective category seat or on an open category seat. If he/she opts for the reserved category he/she will be deemed to have been admitted as an open category candidate and not as reserved category candidate. One seat in the college where he/she was eligible for admission against open seat shall be earmarked for a candidate belonging to the respective reserved category. Such earmarked seat will be made available immediately to the successive reserved category candidate from the same category merit.

12. Cut-off date for the eligibility: The eligibility of candidate shall be determined for all purposes including the applicability of all these Rules & Regulations by considering the last date of physical document verification process at allotted college. It is made abundantly clear that if a candidate is found ineligible or has an invalid reservation claim as on the last date of submission of physical document verification process, in terms of these Rules & Regulations, and if such an ineligible candidate/invalid reservation claim acquires the requisite eligibility after the aforesaid cut off date (i.e. the last date of physical document verification process), such subsequent acquisition of eligibility will not make an ineligible candidate / invalid reservation claim eligible / valid for any purpose whatsoever.

13. PHYSICAL DOCUMENT VERIFICATION PROCESS

The Candidate will have to report at the allotted college with her/his Original Documents for physical verification and admission. The candidate should report personally (**proxy not allowed**) to the respective allotted College, for the physical Document Verification and admission.

Note:

- 1) Category candidates who do not have Caste Validity Certificate at the time of Physical document verification process, will be considered as Open merit candidates subject to fulfilling eligibility.
- 2) DT -A(VJ), NT-B, NT-C, NT-D, OBC and SBC category candidates who do not have Non Creamy Layer (valid up to 31/03/2022) at the time of physical document verification process will be considered as Open Merit candidates subject to fulfilling eligibility.
- 3) Such category candidates without validity and / or NCL, who are considered as Open Merit candidate will be made eligible, if he/she is other wise eligible for open category.

- 4) Applicants belonging to SBC: The person belonging to Special Backward Class (SBC) is to be considered as OBC candidate and such candidate will be required to produce Non- Creamy Layer Certificate. **(Annexure- C)**
- 5) EWS Category candidates who do not have EWS Eligibility Certificate valid for Academic Year 2021-22 at the time of Physical document verification process, will be considered as Open merit candidates subject to fulfilling eligibility.

14. PROVISIONAL STATE MERIT LIST (SML):

- 14.1 The Competent Authority will prepare Provisional State Merit Lists of eligible candidates in PGP-CET-2021/PGO-CET-2021/ M.Sc (SLP) /M.Sc (Aud)-CET-2021/M.Sc (P & O) CET-2021 on the basis of the marks obtained by the candidates at the PG Entrance Examination.
- 14.2 The candidate will be selected on the basis of the provisional merit in PGP-CET-2021/PGO-CET-2021/ M.Sc (SLP) /M.Sc (Aud)-CET-2021/M.Sc (P&O) CET-2021, entrance test to the concerned course.
- 14.3 TIE-BREAKER for determination of the Inter-se-merit of candidates obtaining equal PGP-CET / PGO-CET / M.Sc (SLP) /M.Sc (Aud)-CET / M Sc. (P & O)-CET marks.

In case two or more candidates obtain equal marks in the PG entrance examination, the inter-se-merit of such candidates will be determined in the order of preference as under:-

- 14.3.1 The candidate with higher aggregate marks (converted into percentage) at First, Second, Third and Fourth year Examinations of B.P.Th / B.O.Th. taken together & at First, Second and Third year Examinations of B.A.S.L.P/ BPO taken together shall be preferred. If the tie still persists.
- 14.3.2 The candidate with more marks (converted into percentage) at fourth year B.P.Th / B.O.Th or third year B.A.S.L.P / BPO examination will be preferred. If the tie still persists.
- 14.3.3 The candidate with more marks (converted into percentage) at third year B.P.Th / B.O.Th or second year B.A.S.L.P / BPO examination will be preferred. If the tie still persists.
- 14.3.4 An older candidate will be preferred over a younger candidate.
- 14.3.5 While considering aggregate marks for above purpose, **grace marks & NSS marks** will not be taken into account.

15. ONLINE PREFERENCE FILLING PROCESS AND SELECTION PROCESS BY CAP COMPUTERISED ROUND: The details of State Quota seat matrix available for counseling and Schedule of online preference form filling process will be published in due course.

15.1 Admission to postgraduate courses for academic year 2021-22, will be done online by way of filling of the online "Preference Form" on www.mahacet.org. The selection of the candidates will be made on the basis of preferences given by the candidate. Seat allocation shall be made centrally at a later date on the basis of State merit in the state of Maharashtra, and preferences exercised by the candidate.

The candidate can fill online preference form multiple times before clicking submit button. Once submit button is clicked, then there is no provision to change the preference(s). These preference(s) will be used for first round and subsequent round(s) of selection/up gradation (if any). Up gradation in subsequent rounds is compulsory.

15.2 There shall be two or more rounds of selection of candidates depending on the availability of vacant seats. The selection will be on the basis of merit and the preferences submitted by the candidate. For second and subsequent rounds (if any) no separate online preferences will be filled by the candidate. The choices of courses and colleges once entered online shall be final and irrevocable. This final data shall be used in entire selection process.

15.3 **The Subject & College combination code** is a four digit number specific for each college & Subject combination. **(Annexure – P)** Candidate can fill minimum one preference and maximum available preferences for available subjects. It is not compulsory to fill all Preferences. The first two digit of the code indicates specific college/institution and last two digit indicates particular subject. eg.

- 4) Fee for Institutional quota including NRI in private unaided college will be made available on website of the concerned college in due course.
- 5) The candidate should verify the fee structure of State/ Institutional / NRI Quota Seats prescribed by Fee Regulating Authority, before filling online preferences. The FEE STRUCTURE of Private and Minority medical colleges is available on website of Fee Regulating Authority i.e- www.sssamiti.org

15.6 In second round if number of seat is increased in the existing seat(s) in the same subject & in the same institute then fresh preferences will not be called. While submitting the choices students should note this point.

- 15.7 Candidate should fill his most preferred subject and college code as preference no. 1 followed by his next choice as preference no. 2 and so on. While filling the subject and college codes, four digit number should be entered in boxes of PGP/PGO/ M.Sc (SLP) /M.Sc (Aud)/MSc (P&O) CET 2021 preference form.
- 15.8 Candidate must be very careful while filling the preference form. Candidate can fill minimum one preference or any desired number of preferences for PGP/PGO/ M.Sc (SLP) /M.Sc (Aud)/MSc (P&O) CET 2021.
- 15.9 If a candidate does not give preference for a particular code (Government / Corporation / Private); then it means that he / she is not interested / desiring to take that PG seat. Candidate should note that there will be no change / addition / deletion in his / her list of preferences at later date / stage.
- 15.10 Candidates may kindly note while filling the preference form that PGP/PGO/ M.Sc (SLP) /M.Sc (Aud)/MSc (P&O) CET 2021 merit list will be operated from State Merit number one onwards in each round of selection. Candidate getting selected in previous round will be considered for the betterment for the subsequent rounds. The betterment herein means the higher preference exercised by the candidate. The shift in such betterment shall be compulsory and mandatory except for those who have filled the **Status Retention form**. Such a candidate who has filled status retention form will not be considered for any subsequent rounds of selection process for the Academic year 2021-22. The last date for filling status retention form will be notified along with the selection list.
- 15.11 **Status Retention:** In case if a candidate to whom a seat has been allotted in the first round and who has joined the college accordingly, is satisfied with the allotment, such a candidate must submit a Status-Retention Form (**Annexure-M**) in the given format on or before prescribed date with the Dean/Principal of the College where such a seat has been allotted to such a candidate. The Dean of every College in which admissions are so made in terms of these rules, may appoint an appropriate Officer to receive such Status Retention Forms. Upon receipt of such Status Retention Forms, an acknowledgement in writing shall be issued immediately to the concerned candidates by the officer appointed by the Dean of concerned college. It is mandatory for every such candidate submitting a Status Retention Form to insist for issuance of acknowledgement thereof and to preserve such acknowledgement till the present admission process is finally concluded. In absence of such an acknowledgement, the claim of submission of Status Retention Form within the prescribed time shall not be entertained. Candidate who has submitted status retention forms will not be eligible for remaining subsequent round(s).
- It is hereby made clear that the period provided for submission of Status Retention Form is crucial and vital. This period shall not be extended for**

any reason whatsoever. Submission of the Status Retention Form is an irrevocable and irreversible act for the candidate submitting such Status Retention Form. It is made clear that under no circumstances whatsoever, a candidate will be allowed to submit a Status Retention Form after the aforesaid last date. Under any circumstances whatsoever, a candidate who has submitted a Status Retention Form shall not be allowed to withdraw the same. All the candidates therefore, should take the note of this before submission of such a Status Retention Form.

Names of all the candidates who have submitted the Status Retention Form as above within the prescribed time and the seats occupied by them will be removed out of consideration for the remaining admission process

15.12 Based on preferences given, the seats will be allotted on merit and the allotment will be displayed on website of State CET Cell 'www.mahacet.org'. All the candidates to whom a seat has been allotted in the 1st round on the basis of Merit-cum-Preference will have to compulsorily join the college and course so allotted, within prescribed period as per schedule by completing the requisite formalities. i.e. submission of all original document and a set of attested photocopies of each documents as per the list given in PGP/PGO/ M.Sc (SLP) /M.Sc (Aud)/MSc (P&O) CET 2021 Information Brochure and payment of requisite fees in respective institution.

15.13 If a candidate gets selected for a particular MPTh, MOTH, Speech - Language Pathology [M.Sc (Aud./M.Sc.SLP)], MSc (P&O) course, then the candidate is required to join that course as per the procedure. In case he /she does not join the course, he / she will not be eligible for subsequent admission process of PGP-CET /PGO-CET / M.Sc (SLP) /M.Sc (Aud) -CET & M.Sc (P&O) - CET 2021.

15.14 **It is made clear that even if a candidate to whom a seat has been allotted in the 1st round wants a betterment of his/her choice, such a candidate must initially accept the allotment and join the college by completing the necessary formalities as set out by these Rules, failing which such a candidate will not be Eligible for all further CAP round(s) including MOP-UP round(s) for academic year 2021-2022.**

If any candidate to whom a seat has been allotted in the 1st round does not join the college and course seat so allotted, it will be presumed that such a candidate is not interested in the admission process and for all further CAP round(s) including MOP-UP round(s) of admission, such candidate shall not be considered for allotment of any seat.

The seat so allotted to such a candidate who does not join, will be presumed to be a vacant seat as on and from the next date after the date

set out as the last date for joining the college in terms of such allotment. Such a vacant seat will be allotted in the next round of admission process within prescribed period.

15.15 All the candidates who have filled the preference form and to whom a seat could not be allotted in the first round will be held eligible for allotment of a seat in the subsequent Round(s).

15.16 After concluding the first round, for further round(s) candidate who has been allotted a seat in the earlier round and joined the course, as also the candidate(s) who have not been allotted any seat, will be eligible. In the subsequent round(s), betterment chance(s) will be given to the candidate(s) who have already been allotted seat(s). After selection in any round if a candidate fails to join the college, he/she will be ineligible for subsequent admission process.

15.17 After the first round, Competent Authority may conduct subsequent CAP round(s), based on the same preference form, and no separate preference shall be required to be filled by the candidate. For these subsequent computerized CAP round(s) those candidates who are **(a)** selected but not joined, **(b)** a filled status retention form **(c)** joined and resigned after allotment of seat(s) **(Annexure-K)** and **(d)** Joined but not working in institution will not be considered eligible for further CAP round(s) including MOP-UP round(s) admission process. **However such a candidate who does not have any seat in hand shall be considered eligible for institutional level round.**

15.18 **PWD vacant seats** If the seats reserved for the person with disabilities in a particular category remain unfilled an account of unavailability of candidates the seats shall be inculcated in the annual sanctioned seats for the respective category and allotted as per the preferences (choices) already exercised by the eligible candidate(s) during online preference filing system.

15.19 **Mop-Up Round (s)** : After conducting two CAP rounds of seat allotments for Government/ Corporation and State quota of Central Government/Government Aided / Unaided Private/Minority Medical colleges, if seat(s) remain vacant due to non allotment, non reporting for admission and resigning after joining or any other reason, such seats will be filled in **Mop-Up round(s)**. The details of the CAP Mop Up round(s) will be declared by way of notice on the website in due course.

A) Eligibility for MOP-UP Round(s):

1. All candidates admitted in 1st round, 2nd round and secured the admission but not filled status retention form.
2. All the candidates who are wait listed and to whom choice was not available during 1st round and 2nd round.

B) Candidates NOT ELIGIBLE for Mop-Up Round(s):

- a) Candidate to whom a seat has been allotted in computerized CAP rounds and not joined
- b) Candidate who has filled status retention form
- c) Those candidates who are joined and resigned after allotment of seats in previous rounds.

16. INSTITUTION LEVEL ROUND FOR VACANT SEATS AFTER CAP Mop-Up ROUNDS:

- 16.1 If the seat(s) remain vacant in Private Unaided /Private Minority Colleges after all CAP Mop-Up Rounds, the said seats shall be filled in by the Institution through Institution Level Round with the prior approval of the Competent Authority. The Dean or Principal of the institutions shall carry out the admission for these vacant seats on the basis of inter-se merit from the list of PGP-CET /PGO-CET/ M.Sc (SLP) /M.Sc (Aud) -CET & M.Sc (P&O) - CET 2021 eligible candidates as per the directions issued by the Competent Authority during academic year 2021-22.
- 16.2 All those candidates joined during CAP 1st round/ 2nd round and Mop-Up round(s) in Government/Corporation/Govt. Aided/ Pvt. Unaided/ Minority Medical colleges and having admitted status as on prescribed date are **NOT ELIGIBLE** to participate in institutional level round.
- 16.3 The list of Eligible candidates for institutional round (i.e. those who are having not admitted status as on prescribed date) will be published on the website www.mahacet.org.
- 16.4 Any issue regarding filling of vacant seats not dealt herein above will be dealt with, when arising fully and finally by the Competent Authority.

17. DISCIPLINE:-

- 17.1 Candidates are advised in their own interest that they should not furnish any particulars that are false, tampered with or fabricated and should not suppress any material information while submitting online application. At the time of examination, or in a subsequent selection procedure, if a candidate is (or has been) found guilty of –
 - (i) using unfair means or
 - (ii) impersonating or procuring impersonation by any person or
 - (iii) misbehaving in the examination hall or disclosing, publishing, reproducing, transmitting, storing or facilitating transmission and storage of contents of the test(s) or any information therein in whole or part thereof in any form or by any means, verbal or written, electronically or mechanically for any purpose or

- (iv) resorting to any irregular or improper means in connection with his/ her candidature or
 - (v) obtaining support for his/ her candidature by unfair means, or
 - (vi) carrying mobile phones or similar electronic devices of communication in the examination hall, such a candidate may, in addition to rendering himself/ herself liable to criminal prosecution, be liable :
 - (a) to be disqualified from the examination for which he/ she is a candidate
 - (b) to be debarred either permanently or for a specified period from any examination conducted by competent Authority.
- 17.2 Adopting an unfair means or engaging in malpractice in the examination shall render a candidate liable for punishment under, “Maharashtra Prevention of Malpractices Act, Universities, Board and Other Specified Examination Act, 1982” and disqualify him/her for PGP-CET2021/PGO-CET2021/ M.Sc (SLP) /M.Sc (Aud) -CET 2021 & Ms.(P&O)-CET 2021 examination.
- 17.3 All candidates selected for admission shall be subject to the disciplinary rules of the Institution, University and Government and local authority.

18. UNDERTAKING:

Candidate selected for postgraduate course will be required to submit an undertaking for completion of course failing which he/she will be required to pay Rs.3,00,000/- for the default (i.e. non completion of course). However, this is not applicable to the candidates of PGP-CET-2021 / PGO-CET-2021 / M.Sc (SLP) /M.Sc (Aud) -CET-2021 / M Sc.(P&O)-CET- 2021 resigning the course before prescribe date. This date will be notified by the Competent Authority in due course.

- 19.** Any issue not dealt here-in above will be dealt with, when arising, fully and finally by the Competent Authority and Commissioner, State CET Cell, Mumbai

20. GRIEVANCE REDRESSAL MECHANISM:

As per section 9 of the act any grievance regarding the examination and admissions will lie before the Admissions Regulation Authority.

- 21. LEGAL JURISDICTION:** All disputes pertaining to the conduct of examination process shall fall within the jurisdiction of courts in Mumbai only.

Annexure “A”

DEFINITIONS

Unless the context other requires,

- (a) “**Act**” means the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 (Mah. Act XXVIII of 2015);
- (b) “**Competent Authority**” means the Commissioner of State CET appointed by the Government under section 10, for conducting CET through CAP for the admissions into Private Professional Educational Institutions ;
- (c) “**Admission Reporting Institution**” means a institution where the Candidate shall report for confirmation of admission by submission of documents and payment of fees;
- (d) “**Application Form**” means the prescribed form to be filled up for online or offline by the candidate for admission to the Courses as defined in clause (f);
- (e) “**CAP Seats**” means the seats filled in through the Centralized Admission Process(CAP) carried out by the Competent Authority;
- (f) “**Document Verification Centre**” means the city or town where the document verification is to be conducted;
- (g) “**Foreign Student**” means a student who is not a citizen of India;
- (h) “**Non-Resident Indian (NRI)**” means a person who is “not ordinarily resident” under sub-section (6) of section 6 of the Income Tax Act, 1961, and includes a person resident outside India under clause (w) of section 2 of the Foreign Exchange Management Act, 1999, and also includes his child or ward;
- (i) “**Person of Indian Origin (PIO)**” means a person who is a citizen of a country other than India but who, at any time, was a citizen of India; or in whose case either parent or any grandparent was a citizen of India by virtue of the provisions of Part II of the Constitution of India or under the Citizenship Act, 1955;
- (j) “**Eligible Candidates**” means the candidates who are eligible for different professional courses as notified by the Government, from time to time, under sub-section (1) of section 3 of the Act;
- (k) “**Inter-se-Merit**” means the order of merit in respect of various classes, category and candidature types of the Candidates determined by following the CET merit in accordance with these rules;
- (l) “**Institutional Quota**” means the seats available for admission to eligible Candidates at Institution level as declared by the State Government or the appropriate authority, from time to time;
- (m) “**Minority Educational Institution**” means a Private Professional Educational Institution notified as such by the State Government, established and administered for and by the persons belonging to the minority community, domiciled in the State of Maharashtra, having right to do so under clause (1) of article 30 of the Constitution of India;
- (n) “**management**” means the managing committee or the governing body, by whatever name called, of the Private Professional Educational Institution to which the affairs of such Institution are entrusted and where such affairs are entrusted to any person, by whatever name or designation called, includes such person;
- (o) “**Nodal Officer**” means the Director of the Medical Education and Research
- (p) “**Private Professional Educational Institution**” means any college, school, institute, institution or other body, by whatever name called, conducting any professional course or courses approved or recognized by the appropriate authority and affiliated to any university, but shall not include,—
 - (i) any such institution established, maintained or administered by the Central Government, any State Government or any local authority;
 - (ii) institution declared to be a deemed university under section 3 of the University Grants Commission Act, 1956 ; or
 - (iii) a university to which the provisions of the University Grants Commission (Establishment and Maintenance of Private Universities) Regulations, 2003 are applicable;
- (q) “**Professional Education**” means any educational course of study declared and notified as such, from time to time by the Government which includes a course leading to the award of an Under Graduate or Post-Graduate degree, diploma, by whatever name called and recognized by the appropriate authority;
- (r) “**regulations**” means the regulations framed by the Regulating Authorities;

- (s) **“Regulating Authority”** means the Admissions Regulating Authority under section 7 or the Fees Regulating Authority under section 11, as the case may be ;
- (t) **“sanctioned intake”** means the total number of seats sanctioned or approved by the appropriate authority for admitting candidates in a single academic year in each professional course of study or discipline in a Private Professional Educational Institution at the appropriate level of entry;
- (u) **“unaided institution”** means Private Professional Educational Institution, which is not receiving aid or grant-in-aid from the Central Government, the State Government or the local authority;
- (v) **“University”** shall have the same meaning as assigned to it in clause (f) of section 2 of the University Grants Commission Act, 1956.
- (w) **‘Postgraduate Teacher’** means the teacher who is recognised as a postgraduate teacher under the regulation of MUHS / Conventional non agricultural Universities in the state.
- (x) **‘Recognised Qualification’** means the qualification recognised by the University in the State of Maharashtra.
- (y) **‘Reservation’** means the reservation prescribed by the Government of Maharashtra for admission to Postgraduate Courses which includes both Constitutional Reservation for the Backward Classes & other reservations, if any.
- (z) **‘University’** means the non agricultural Universities constituted under the Maharashtra University Act, 1994 and MUHS constituted under MUHS Act, 1998.
- (aa) **‘BMC’** means Brihanmumbai Municipal Corporation, Mumbai
- (bb) **‘CVC’** means Caste Validity Certificate.
- (cc) **‘NCL’** means Non Creamy Layer Certificate.
- (dd) **‘MUHS’** means Maharashtra University of Health Sciences
- (ee) **‘BPT h’** means Bachelor of Physiotherapy
- (ff) **‘MPT h’** means Master of Physiotherapy
- (gg) **‘BOTH’** means Bachelor of Occupational therapy
- (hh) **‘MOTH’** means Master of Occupational therapy
- (ii) **‘BASLP’** means Bachelor of Audiology & Speech Language Pathology
- (jj) **‘M.Sc Audiology’** means Master of Science in Audiology
- (kk) **‘MASLP’** means Master of Audiology & Speech Language Pathology
- (ll) **‘M.Sc. SLP’** means Master of Science in Speech Language Pathology
- (mm) **‘BPO’** - means Bachelor of Prothotics & Orthotics.
- (nn) **‘SC’** means Scheduled Caste
- (oo) **‘ST’** means Scheduled Tribes
- (pp) **‘VJ’** means Vimukta Jati
- (qq) **‘NT’** means Nomadic Tribes
- (rr) **‘OBC’ means Other Backward Class**
- (ss) **‘SBC’** means Special Backward Class
- (tt) **“Orphan”** means a child— (i) who is without biological or adoptive parents or legal guardian; or (ii) whose legal guardian is not willing to take, or capable of taking care of the child; as defined in Juvenile Justice (Care and Protection of Children) act 2015
- (uu) **‘RCI’** means Rehabilitation Council of India established under Rehabilitation Council Act, 1992. (RCI is under the Ministry of Social Justice & empowerment Government of India)

- 1) The candidates recognized by the State of Maharashtra as belonging to the following Backward Classes, shall alone be eligible to claim admissions as against the seats reserved for such backward class categories. The constitutional reservation at Government/ Corporation Institutes and Private unaided Institutes is as mentioned below.

- 2) Candidates belonging to aforesaid Backward Class categories will be required to submit the Caste Certificate and the Caste/Tribe Validity Certificate at the time of documents verification.
- 3) Caste certificate issuing authority: - Caste certificate stating that the caste is recognized under a particular backward class category in Maharashtra state is issued by Sub-Divisional Magistrate/Executive Magistrate/Metropolitan Magistrate in Maharashtra state.
- 4) The Caste/Tribe validity Certificate issuing Authorities are as follows:-
- For Candidates belonging to Scheduled Caste, Scheduled Caste converts to Buddhism, Vimukta Jati, Nomadic Tribes^{1,2&3} and Other Backward Class, Caste Validity Certificate is issued by **Divisional Caste Certificate Scrutiny Committee of respective Divisional Social Welfare Office** (Konkan, Pune, Nashik, Aurangabad, Amravati and Nagpur).
 - For Candidates belonging to Scheduled Tribe the Tribe Validity Certificate is issued by Director/Deputy Director, **Tribe Certificate Scrutiny Committee of respective Region** (Konkan, Pune, Nashik, Aurangabad, Amravati and Nagpur).
- 5) **A) The candidate should have claimed the constitutional reservation in the original application form.** The candidate claiming constitutional reservation must submit original caste validity certificate at the time of Physical document verification process, failing which the category claim will not be granted.
- B) The candidate should have claimed the Economically Weaker Section reservation in the original application form.** The candidate claiming EWS quota reservation must submit EWS eligibility certificate at the time of Physical

document verification process, failing which the category claim will not be granted.

6) NON-CREAMY LAYER

A candidate belonging to 'Creamy Layer' amongst the categories (C) to (G) must note that the provision of reservation is NOT applicable to him/her. A candidate claiming benefit of reservation under the categories (C) to (G) above will be required to produce Non-Creamy layer certificate as specified in the Government resolution CBC-10/2008/CR-697 VJNT-1, dated 24th June, 2013. The certificate should have valid upto 31/03/2022. The Non-Creamy Layer Certificate is issued by Sub-Divisional Officer/Deputy Collector/Collector of the district.

However, such a Non-Creamy Layer Certificate shall be produced in any case at the time of filling up of Preference Form, failing which the category claimed will not be granted.

Applicants belonging to Special Backward Class

N.B.: As per Maharashtra Act No. XXX of 2006 dated 01 August 2006, the persons belonging to Special Backward Class (SBC) are to be considered as OBC candidates.

7) Inter-se amongst the reserved categories will be operated at the end of each admission process against the unfilled reserved categories seats as per merit and choice of the reserved categories candidates.

The seats remaining vacant from various categories will be filled in during inter-se admission process as follows:

a) From among the candidates of their respective group from the Interse State Merit List of that particular group where the vacancies exist.

A -The groups are as follows -

GROUP - I
(i) Scheduled Castes and Schedule Caste converted to Buddhism (S.C.) (ii) Scheduled Tribes including those living out-side specified area (S.T.)
GROUP - II
(i) Vimukta Jati (VJ)(DT-A) (ii) Nomadic Tribes (NT-B)
GROUP - III
(i) Nomadic Tribes (NT-C) (ii) Nomadic Tribes (NT-D) (iii) Other Backward Classes (OBC) including SBC

(b) If the seats still remain vacant, then the seats will be filled, from among the candidates of all the categories mentioned above from the all categories combined merit list.

(c) If the seats still remain vacant then the seats will be filled from among the candidates of the common merit list.

B -The seats remaining vacant from EWS category will be allotted to general Category candidate.

8) **Ear-Marking** : Reserved category candidate entitled to admission on the basis of merit in an open category seat will have the option of taking admission either against his/her respective category seat or on an open category seat. If he/she opts for the reserved category he/she will be deemed to have been admitted as an open category candidate and not as reserved category candidate. One seat in the college where he/she was eligible for admission against open seat shall be earmarked for a candidate belonging to the respective reserved category. Such earmarked seat will be made available immediately to the successive reserved category candidate from the same category merit.

Admission under constitutional reservation seat will be governed by the Maharashtra Schedule Castes, Scheduled Tribes, Denotified Tribes (Vimukta Jatis), Nomadic Tribes, Other Backward Classes and Special Backward Category (Regulation of Issuance and Verification of) Caste Certificate Act, 2000 (Mah. Act No. XXIII of 2001).

भारतीय आयुर्विज्ञान परिषद के अधिक्रमण में शासी बोर्ड

अधिसूचना

नई दिल्ली, 13 मार्च, 2019

सं.भा.आ.प.-18(1)/2018-मेड./187262.—भारतीय आयुर्विज्ञान परिषद् (अधिनियम, 1956(1956 का 102) की धारा 33 द्वारा प्रदत्त शक्तियों का इस्तेमाल करते हुए, भारतीय आयुर्विज्ञान परिषद् के अधिक्रमण में शासी बोर्ड, "स्नातकोत्तर चिकित्सा शिक्षा विनियमावली, 2000" में पुनः संशोधन करने के लिए केंद्र सरकार की पूर्व स्वीकृति से एतद्वारा निम्नलिखित विनियम बनाती है, नामतः-

- (i) ये विनियम, "स्नातकोत्तर चिकित्सा शिक्षा (संशोधन) विनियमावली, 2019" कहे जाएंगे।
(ii) ये सरकारी राजपत्र में उनके प्रकाशन की तारीख से प्रवृत्त होंगे।
- "स्नातकोत्तर चिकित्सा शिक्षा विनियमावली, 2000" के "स्नातकोत्तर छात्रों का चयन" शीर्षक के अंतर्गत खंड 9 (5) को निम्नलिखित रूप में प्रतिस्थापित किया जाएगा :-

परंतु यह भी कि सरकारी या सरकारी सहायता प्राप्त उच्च शैक्षिक संस्थानों में वार्षिक स्वीकृत प्रवेश क्षमता की 5% सीटें, स्नातकोत्तर चिकित्सा पाठ्यक्रमों में दाखिले के लिए 'राष्ट्रीय पात्रता व प्रवेश परीक्षा' की मेरिट सूची के आधार पर, विकलांग व्यक्तियों के अधिकार अधिनियम, 2016 के उपबंधों के अनुसार बैचमार्क विकलांगताओं वाले अभ्यर्थियों द्वारा भरी जाएंगी। इस उद्देश्य के लिए, विकलांग व्यक्तियों के अधिकार अधिनियम, 2016 की अनुसूची में दी गई "विनिर्दिष्ट विकलांगता" परिशिष्ट 'III' में संलग्न की गई है और विनिर्दिष्ट विकलांगता के साथ, चिकित्सा पद्धति में पाठ्यक्रम में पढ़ने वाले अभ्यर्थियों की पात्रता, परिशिष्ट 'IV' के अनुसार होगी। यदि किसी श्रेणी विशेष में, विकलांग व्यक्तियों के लिए आरक्षित सीटें, अभ्यर्थियों की अनुपलब्धता के कारण खाली रह जाती हैं तो ये सीटें, संबंधित श्रेणी के लिए वार्षिक स्वीकृत सीटों में शामिल की जानी चाहिए।

किमी शैक्षिक वर्ष के लिए स्नातकोत्तर पाठ्यक्रम में दाखिले का पात्र बनने की दृष्टि से किसी अभ्यर्थी के लिए यह आवश्यक होगा कि वह उम शैक्षिक वर्ष के लिए आयोजित "स्नातकोत्तर पाठ्यक्रमों के लिए राष्ट्रीय पात्रता व प्रवेश परीक्षा" में 50 वें पर्सेंटाइल पर न्यूनतम अंक प्राप्त करें। तथापि, अनुसूचित जातियों, अनुसूचित जनजातियों और अन्य पिछड़ा वर्ग से संबंधित अभ्यर्थियों के संबंध में न्यूनतम अंक 40वें पर्सेंटाइल पर होंगे। विकलांग व्यक्तियों के अधिकार अधिनियम, 2016 के अंतर्गत विनिर्दिष्ट बैचमार्क विकलांगताओं वाले अभ्यर्थियों के संबंध में न्यूनतम अंक, सामान्य श्रेणी के लिए 45वें पर्सेंटाइल पर और अ.जा./ अ.ज.जा./ अ.पि.व. के लिए 40वें पर्सेंटाइल पर होंगे।

परिशिष्ट - III

(विनियम 9 (5) देखें)

"विनिर्दिष्ट विकलांगता" धारा 2 के खंड (घ ग) के संबंध में अनुसूची संलग्न की जाती है, जिसमें निम्नलिखित उल्लेख किया गया है :

1. शारीरिक विकलांगता

क. गतिक विकलांगता (मस्कुलोस्केल्टल या तंत्रिय प्रणाली या दोनों की वेदना के परिणामस्वरूप स्वयं और वस्तुओं को लाने ले जाने से जुड़े प्रभेदी क्रियाकलाप करने में किमी व्यक्ति की असमर्थता), जिसमें निम्नलिखित शामिल हैं:-

1 (क) "कुष्ठ रोग मुक्त व्यक्ति" से कोई ऐसा व्यक्ति अभिप्रेत है, जो कुष्ठ रोग से मुक्त हो गया है, परंतु निम्नलिखित से पीड़ित है-

- हाथों और पैरों में संवेदन की कमी और आंख तथा पलक में संवेदन की कमी या आंशिकघात परंतु किमी अभिव्यक्त विरूपता के बिना;
- अभिव्यक्त विरूपता और आंशिकघात परंतु उन्हें सामान्य आर्थिक क्रियाकलाप में लगने में समर्थ बनाने के लिए उनके हाथों और पैरों में पर्याप्त गतिकता वाले व्यक्ति;
- अत्यधिक शारीरिक विरूपता और अधिक आयु जो उसे कोई लाभप्रद व्यवसाय आरंभ करने से रोकती हो, और "कुष्ठ रोग मुक्त" अभिव्यक्ति का अर्थ तदनुसार लगाया जाएगा;

ख. "प्रमस्तिष्कीय पक्षाघात" से अभिप्रेत है - आमतौर पर जन्म से पहले, के दौरान, या जन्म के शीघ्र पश्चात् होने वाली, मस्तिष्क के एक या अधिक विनिर्दिष्ट क्षेत्र को पहुंची क्षति के कारण शरीर के संचलन और मांसपेशियों के समन्वय को प्रभावित करने वाली गैर-प्रभावी तंत्रिका संबंधी स्थिति का एक समूह;

ग. "बौनापन" से अभिप्रेत है- एक मेडिकल या आनुवंशिक स्थिति जिसके परिणामस्वरूप किसी वयस्क की ऊंचाई 4 फीट 10 इंच (147 सेंटीमीटर) या इससे कम हो;

- घ. "मांसपेशीय डिस्ट्रॉफी" से अभिप्रेत है- आनुवंशिक मांसपेशी रोग का एक ऐसा समूह जो उन मांसपेशियों को कमजोर करता है, जो मानव शरीर का संचालन करती है, और बहुत डिस्ट्रॉफी वाले व्यक्तियों के पास उनके जीन्स में गलत और गायब सूचना होती है जो उन्हें ऐसे प्रोटीन्स बनाने से रोकती है, जिनकी स्वस्थ मांसपेशियों के लिए आवश्यकता होती है। इसके लक्षण हैं- प्रगामी स्कैल्टन मांसपेशी की कमजोरी, मांसपेशी प्रोटीन्स में दोष और मांसपेशियों के कोशाणुओं तथा ऊतकों की मृत्यु।
- ङ. "तेजाब प्रहार पीडित" से अभिप्रेत है- तेजाब या इसी प्रकार के संधारक पदार्थ फेंके जाने से हिंसक प्रहार के कारण कोई विरूपित व्यक्ति।
- च. चाक्षुष क्षति-
- (क) "नेत्रहीनता" से अभिप्रेत है- एक ऐसी स्थिति, जहां किसी व्यक्ति में सर्वोत्तम सुधार के पश्चात भी निम्नलिखित में से कोई स्थिति हो :
- (i) दृष्टि का पूर्ण अभाव; या
- (ii) सर्वोत्तम संभव सुधार के साथ बेहतर आंख में 3/6 से कम या 10/200 से कम (स्नेलन) चाक्षुष तीक्ष्णता हो; या
- (iii) दृष्टि के क्षेत्र की वह सीमा, जो 10 डिग्री से कम का कोण कक्षांतरित करती हो।
- (ख) "निम्न दृष्टि" से एक ऐसी स्थिति अभिप्रेत है, जहां किसी व्यक्ति में निम्नलिखित में से कोई स्थिति हो, नामतः
- (i) सर्वोत्तम संभव सुधारके साथ बेहतर आंख में अधिक से अधिक चाक्षुष तीक्ष्णता 6/18 या 20/60 से कम, 3/60 तक या 10/200 (स्नेलन) हो; या
- (ii) दृष्टि के क्षेत्र की वह सीमा, जो 40 डिग्री से कम 10 डिग्री तक का कोण कक्षांतरित करती हो।
- (ग) श्रवण क्षति-
- (क) "बधिर" से ऐसे व्यक्ति अभिप्रेत है, जिन्हें दोनों कानों में वाक् फ्रीक्वेंसीज में 70 डीबी श्रवण क्षति हो;
- (ख) "कम सुनने वाला" से ऐसा व्यक्ति अभिप्रेत है, जिसे दोनों कानों में वाक् फ्रीक्वेंसीज में 60 डीबी से 70 डीबी की श्रवण क्षति हो।
- (घ) "वाक् और भाषा विकलांगता" से अभिप्रेत है- आंगिक या तंत्रिका संबंधी कारणों से वाक् और भाषा के एक से अधिक संघटकों को प्रभावित करने वाली स्वरयंत्र उच्छेदन या वाचाघात जैसी स्थितियों से उत्पन्न एक स्थायी विकलांगता।
2. बौद्धिक विकलांगता एक ऐसी स्थिति है, जिसके लक्षण हैं- बौद्धिक कार्यचालन (तर्कणा, ज्ञानार्जन, समस्या समाधान) और अनुकूली व्यवहार दोनों में महत्वपूर्ण सीमा, जो दिन प्रति दिन के सामाजिक और व्यावहारिक कौशलों की एक रेंज कवर करती है, जिसमें निम्नलिखित शामिल हैं :
- (क) "विनिर्दिष्ट ज्ञानार्जन विकलांगताएं" से अभिप्रेत है ऐसी स्थितियों का एक विजातीय समूह, जिसमें भाषा, बोली जाने वाली या लिखित, प्रोसेसिंग में कोई ऐसी कमी है, जो समझने, बोलने, पढ़ने, लिखने, हिज्जे करने या गणितीय परिकलन करने में एक कठिनाई के रूप में स्वयं को अभिव्यक्त कर सकती है और इसमें बोधात्मक विकलांगताएं, डिस्लेक्सिया, डिस्ग्राफिया, डिस्कलकूलिया, डिस्प्रैक्सिया और विकासात्मक वाचाघात जैसी स्थितियां शामिल हैं;
- (ख) "आत्म विमोह स्पेक्ट्रम विकृति" से अभिप्रेत है- जीवन के पहले तीन वर्षों में अलग प्रकार से प्रकट होने वाली एक तंत्रिका- विकासात्मक स्थिति जो व्यक्ति की संसूचित करने, रिश्ते समझने और अन्य के साथ जोड़ने की योग्यता को पर्याप्त रूप से प्रभावित करती है और असामान्य या अपरिवर्तनीय धार्मिक कृत्यों या व्यवहारों के साथ बार-बार संबद्ध है।

3. मानसिक व्यवहार- "मानसिक रोग" से अभिप्रेत है- विचारण, मनोदशा, अवबोधन, अभिमुखीकरण या स्मरण शक्ति, जो जीवन की सामान्य मांगे पूरी करने की योग्यता या वास्तविकता को स्वीकार करने की योग्यता, व्यवहार, निर्णय को भारी मात्रा में क्षति पहुंचाती है परंतु इसमें ऐसी मंदता शामिल नहीं है जो किसी व्यक्ति के मस्तिष्क के अवरोध या अपूर्ण विकास की एक स्थिति है, जिसका विशेष लक्षण, बुद्धि की उप-असामान्यता है।
4. निम्नलिखित के कारण विकलांगता-
- (क) चिरकालिक तंत्रिका संबंधी स्थितियां, जैसे-
- (i) "बहुल ऊतक दृढ़न" से अभिप्रेत है- एक प्रदाहक, तंत्रिका प्रणाली रोग, जिसमें मस्तिष्क और रीढ़ की हड्डी की तंत्रिका कोशिकाओं के अक्षतंतुओं के आस-पास की मेरुमज्जा आच्छादन क्षतिग्रस्त हो जाते हैं, जिसके परिणामस्वरूप डिमाइलोएशन हो जाता है और एक दूसरे के साथ संचारित करने के लिए मस्तिष्क और रीढ़ की हड्डी में तंत्रिका कोशिकाओं की क्षमता प्रभावित हो जाती है;
- (ii) "पार्किन्सन रोग" से अभिप्रेत है- मस्तिष्क के आधारीय गंगलिया के विकार और तंत्रिका संचारी डोपामाइन की किसी कमी के साथ जुड़ी, मुख्यतः मध्य आयु वाले और बुजुर्गों को प्रभावित करने वाली, ठूमर, मांसपेशी की दृढ़ता और धीमी, अस्पष्ट गति के लक्षणों वाली तंत्रिकीय प्रणाली का एक प्रगामी रोग।
- (ख) रक्त विकृति-
- (i) "अधिरक्तस्त्राव" से अभिप्रेत है- एक वंशानुगत रोग, जो आमतौर पर केवल पुरुषों को प्रभावित करता है परंतु महिलाओं द्वारा अपने पुरुष बच्चों में संचारित किया जाता है जिनके लक्षण हैं- रक्त की सामान्य जमाव क्षमता की क्षति या हानि, जिससे किसी अवयस्क को घातक रक्तस्त्राव हो सकता है;
- (ii) "थालासीमिया" से अभिप्रेत है- वंशानुगत विकृतियों का एक ऐसा समूह, जिसके लक्षण हैं- हिमोग्लोबिन की घटी हुई मात्रा या उसका अभाव।
- (iii) "मिकल सैल रोग" से अभिप्रेत है- चिरकालिक रक्ताल्पता, कष्टदायक परिणामों और संलग्न ऊतक तथा अंग क्षति के कारण विभिन्न जटिलताओं के लक्षण वाली एक हेमोलाइटिक विकृति; "हेमोलाइटिक" लाल रक्त की कोशिका झिल्ली के नष्टीकरण से संबंधित है, जिसके परिणामस्वरूप हेमोग्लोबिन निकलता है।
5. बधिर, नेत्रहीनता सहित बहुल विकलांगताएं (ऊपर विनिर्दिष्ट विकलांगताओं में से एक से अधिक) जिससे एक ऐसी स्थिति अभिप्रेत है, जिसमें किसी व्यक्ति को श्रवण और चाक्षुष क्षति का संयोजन हो सकता है, जिसके कारण गंभीर संसूचन, विकासात्मक और शैक्षिक समस्याएं हो सकती हैं।
6. कोई अन्य श्रेणी, जो केंद्र सरकार द्वारा अधिसूचित की जाए।

टिप्पणी: विकलांग व्यक्तियों के अधिकार अधिनियम, 2016 की अनुसूची में किए जाने वाले किसी संशोधन के परिणामस्वरूप उपर्युक्त अनुसूची में संशोधन हो जाएगा।

2. किसी व्यक्ति में "विशिष्ट विकलांगता" की सीमा, 5 जनवरी, 2018 को सामाजिक न्याय एवं अधिकारिता मंत्रालय, [विकलांग व्यक्ति (दिव्यांगजन)सशक्तीकरण विभाग] द्वारा भारत के राजपत्र में अधिसूचित "विकलांग व्यक्तियों के अधिकार अधिनियम, 2016 (2016 का 49) के अंतर्गत शामिल किए गए किसी व्यक्ति में विशिष्ट विकलांगता की सीमा आंकने के उद्देश्य के लिए दिशानिर्देश" के अनुसार आंकी जाएगी।
3. विशिष्ट विकलांगता वाले व्यक्तियों के लिए आरक्षण का लाभ प्राप्त करने की दृष्टि से विकलांगता की न्यूनतम डिग्री 40%(बैचमार्क विकलांगता) होनी चाहिए।
4. "शारीरिक रूप से विकलांग" (शा.वि.) शब्द के बजाए 'विकलांग व्यक्ति' (वि.व्य.) शब्द का इस्तेमाल किए जाएगा।

BOARD OF GOVERNORS IN SUPER SESSION OF MEDICAL COUNCIL OF INDIA

NOTIFICATION

New Delhi, the 13th March, 2019

No.MCI_18(I)/2018-Med/187262.—In exercise of the powers conferred by Section 33 of the Indian Medical Council Act, 1956 (102 of 1956), the Board of Governors in Super-session of Medical Council of India with the previous sanction of the Central Government, hereby makes the following Regulations to further amend the "Postgraduate Medical Education Regulations, 2000", namely: -

1. (i) These Regulations may be called the "Postgraduate Medical Education Regulations(Amendment), 2019.
- (ii) They shall come into force from the date of their publication in the Official Gazette.
2. In the "Postgraduate Medical Education Regulations, 2000", under the heading of "Selection of Postgraduate Students" clause 9 (5) shall be substituted as under:-

Provided further that 5% of the annual sanctioned intake capacity in Government or Government aided higher educational institutions shall be filled up by candidates with benchmark disabilities in accordance with the provisions of the Rights of Persons with Disabilities Act, 2016, based on the merit list of 'National Eligibility-cum-Entrance Test' for admission to Postgraduate Medical Courses. For this purpose, the "Specified Disability" contained in the

Schedule to the Rights of Persons with Disabilities Act, 2016 is annexed in Appendix 'III' and the eligibility of candidates to pursue a course in medicine with specified disability shall be in accordance with Appendix 'IV'. If the seats reserved for the persons with disabilities in a particular category remain unfilled on account of unavailability of candidates, the seats should be included in the annual sanctioned seats for the respective Category.

In order to be eligible for admission to Postgraduate Course for an academic year, it shall be necessary for a candidate to obtain minimum of marks at 50th percentile in the 'National Eligibility-Cum-Entrance Test for Postgraduate courses' held for the said academic year. However, in respect of candidates belonging to Scheduled Castes, Scheduled Tribes, and Other Backward Classes, the minimum marks shall be at 40th percentile. In respect of candidates with benchmark disabilities specified under the Rights of Persons with Disabilities Act, 2016, the minimum marks shall be at 45th percentile for General Category and 40th percentile for SC/ST/OBC.

Appendix III

(Refer Regulation 9(5))

A SCHEDULE is annexed regarding, "SPECIFIED DISABILITY" clause (zc) of section 2, that states as under,

1. Physical disability

A. Locomotor disability (a person's inability to execute distinctive activities associated with movement of self and objects resulting from affliction of musculoskeletal or nervous system or both), including—

(a) "leprosy cured person" means a person who has been cured of leprosy but is suffering from—

- (i) loss of sensation in hands or feet as well as loss of sensation and paresis in the eye and eye-lid but with no manifest deformity;
 - (ii) manifest deformity and paresis but having sufficient mobility in their hands and feet to enable them to engage in normal economic activity;
 - (iii) extreme physical deformity as well as advanced age which prevents him/her from undertaking any gainful occupation, and the expression "leprosy cured" shall construed accordingly;
- (b) "cerebral palsy" means a Group of non-progressive neurological condition affecting body movements and muscle coordination, caused by damage to one or more specific areas of the brain, usually occurring before, during or shortly after birth;
- (c) "dwarfism" means a medical or genetic condition resulting in an adult height of 4 feet 10 inches (147 centimeters) or less;
- (d) "muscular dystrophy" means a group of hereditary genetic muscle disease that weakens the muscles that move the human body and persons with multiple dystrophy have incorrect and missing information in their genes, which prevents them from making the proteins they need for healthy muscles. It is characterized by progressive skeletal muscle weakness, defects in muscle proteins, and the death of muscle cells and tissue; (e) "acid attack victims" means a person disfigured due to violent assaults by throwing of acid or similar corrosive substance.

B. Visual impairment—

- (a) "blindness" means a condition where a person has any of the following conditions, after best correction—
- (i) total absence of sight; or
 - (ii) visual acuity less than 3/60 or less than 10/200 (Snellen) in the better eye with best possible correction; or
 - (iii) limitation of the field of vision subtending an angle of less than 10 degree.
- (b) "low-vision" means a condition where a person has any of the following conditions, namely:—
- (i) visual acuity not exceeding 6/18 or less than 20/60 upto 3/60 or upto 10/200 (Snellen) in the better eye with best possible corrections; or
 - (ii) limitation of the field of vision subtending an angle of less than 40 degree up to 10 degree.

- C. Hearing impairment -
- (a) "deaf" means persons having 70 DB hearing loss in speech frequencies in both ears;
 - (b) "hard of hearing" means person having 60 DB to 70 DB hearing loss in speech frequencies in both ears;
 - D. "speech and language disability" means a permanent disability arising out of conditions such as laryngectomy or aphasia affecting one or more components of speech and language due to organic or neurological causes.
2. Intellectual disability, a condition characterized by significant limitation both in intellectual functioning (reasoning, learning, problem solving) and in adaptive behavior which covers a range of every day, social and practical skills, including—
 - (a) "specific learning disabilities" means a heterogeneous group of conditions wherein there is a deficit in processing language, spoken or written, that may manifest itself as a difficulty to comprehend, speak, read, write, spell, or to do mathematical calculations and includes such conditions as perceptual disabilities, dyslexia, dysgraphia, dyscalculia, dyspraxia and developmental aphasia;
 - (b) "autism spectrum disorder" means a neuro-developmental condition typically appearing in the first three years of life that significantly affects a person's ability to communicate, understand relationships and relate to others, and is frequently associated with unusual or stereotypical rituals or behaviours.
 3. Mental behaviour,— "mental illness" means a substantial disorder of thinking, mood, perception, orientation or memory that grossly impairs judgment, behaviour, capacity to recognize reality or ability to meet the ordinary demands of life, but does not include retardation which is a condition of arrested or incomplete development of mind of a person, specially characterized by subnormality of intelligence.
 4. Disability caused due to—
 - (a) chronic neurological conditions, such as—
 - (i) "multiple sclerosis" means an inflammatory, nervous system disease in which the myelin sheaths around the axons of nerve cells of the brain and spinal cord are damaged, leading to demyelination and affecting the ability of nerve cells in the brain and spinal cord to communicate with each other;
 - (ii) "parkinson's disease" means a progressive disease of the nervous system marked by tremor, muscular rigidity, and slow, imprecise movement, chiefly affecting middle-aged and elderly people associated with degeneration of the basal ganglia of the brain and a deficiency of the neurotransmitter dopamine.
 - (b) Blood disorder—
 - (i) "haemophilia" means an inheritable disease, usually affecting only male but transmitted by women to their male children, characterized by loss or impairment of the normal clotting ability of blood so that a minor would may result in fatal bleeding;
 - (ii) "thalassemia" means a group of inherited disorders characterized by reduced or absent amounts of haemoglobin.
 - (iii) "sickle cell disease" means a hemolytic disorder characterized by chronic anemia, painful events, and various complications due to associated tissue and organ damage; "hemolytic" refers to the destruction of the cell membrane of red blood cells resulting in the release of hemoglobin.
 5. Multiple Disabilities (more than one of the above specified disabilities) including deaf blindness which means a condition in which a person may have combination of hearing and visual impairments causing severe communication, developmental, and educational problems.
 6. Any other category as may be notified by the Central Government.

Note: Any amendment to the Schedule to the RPWD Act, 2016, shall consequently stand amended in the above schedule.

Appendix "IV"

Guidelines regarding admission of students with "Specified Disabilities" under the Rights of Persons with Disabilities Act, 2016 with respect to admission in Postgraduate Courses in Modern Medicine

Note 1. The "Certificate of Disability" shall be issued in accordance with the Rights of Persons with Disabilities Rules, 2017 notified in the Gazette of India by the Ministry of Social Justice and Empowerment [Department of Empowerment of Persons with Disabilities (*Divyangjan*)] on 15th June 2017.

2. The extent of "specified disability" in a person shall be assessed in accordance with the "Guidelines for the purpose of assessing the extent of specified disability in a person included under the Rights of Persons with Disabilities Act, 2016

(49 of 2016)" notified in the Gazette of India by the Ministry of Social Justice and Empowerment [Department of Empowerment of Persons with Disabilities (*Divyangjan*)] on 4th January 2018.

3. The minimum degree of disability should be 40% (Benchmark Disability) in order to be eligible for availing reservation for persons with specified disability.

4. The term 'Persons with Disabilities' (PwD) is to be used instead of the term 'Physically Handicapped' (PH).

MAHARASHTRA UNAIDED PRIVATE PROFESSIONAL EDUCATIONAL INSTITUTIONS (REGULATION OF ADMISSIONS AND FEES) ACT, 2015.

No.CET-3516/C.R. 311/16/Edu-2.—In exercise of the powers conferred by Section 23 of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 (Mah. XXVIII of 2015), the Government of Maharashtra hereby makes the following rules to regulate the admissions to the First Year of the Full Time Professional Post-graduate Courses in Physiotherapy (M.P.Th), Occupational Therapy (M.O.Th), Audiology, Speech and Language Pathology (M.A.S.L.P.) and Prosthetics and Orthotics [M.Sc (P and O)] courses in the Unaided Private Professional Educational Institutions in the State of Maharashtra, namely :—

1. *Short title.*— These rules may be called the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admission to the Full Time Professional Post-graduate Courses in Physiotherapy (M.P.Th), Occupational Therapy (M.O.Th), Audiology, Speech and Language Pathology (M.A.S.L.P.) and Prosthetics and Orthotics [M.Sc (P and O)] courses Rules, 2016.

(2) They shall come into force with effect from the date they are published in the *Gazette*.

2. *Definitions.*—(1) In these rules, unless the context otherwise requires,—

(a) "Act" means the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 (Mah. XXVIII of 2015) ;

(b) "Admission Reporting Institution" means a institution where the Candidate shall report for confirmation of admission by submission of documents and payment of fees;

(c) "Application Form" means the prescribed Form to be filled up for online or offline by the candidate for admission to the Courses as defined in clause (f);

(d) "CAP Seats" means the seats filled in through the Centralized Admission Process (CAP) carried out by the Competent Authority;

(e) "CET" means the Common Entrance Test (CET) conducted for admission to the Courses under this rule;

(f) "Courses" means the Post-graduate Courses in Physiotherapy (M.P.Th), Occupational Therapy (M.O.Th), Audiology, Speech and Language Pathology (M.A.S.L.P.) and Prosthetics and Orthotics [M.Sc (P and O)] Courses, as the case may be, conducted in the State;

(g) "Document Verification Centre" means the city or town where the document verification is to be conducted;

(h) "Eligible Candidates" means the candidates who are eligible for different professional courses as notified by the Government, from time to time, under sub-section (1) of Section 3 of the Act;

(i) "Internship" means the compulsory rotating internship to be completed as per rules of Maharashtra State Council for Occupational Therapy and Physiotherapy Act, 2002 (Mah. II of 2004) and as per the rules of the Rehabilitation Council of India Act, 1992 (34 of 1992), for Audio speech and Language Pathology and Prosthetics and Orthotics and the concerned University;

(j) "Inter-se-Merit" means the order of merit in respect of various classes, category and candidature types of the Candidates determined by following the CET merit in accordance with these rules;

(k) "Institutional Quota" means the seats available for admission to eligible Candidates at Institution level as declared by the State Government or the appropriate authority, from time to time;

(l) "Maharashtrta State Council for Occupational Therapy and Physiotherapy" means The Maharashtra State Council for Occupational Therapy and Physiotherapy Constituted under the Maharashtra State Council for Occupational Therapy and Physiotherapy Act, 2002 (Mah. II of 2004) ;

(m) "Minority Quota" means the seats earmarked for the Minority Community students from within the State, belonging to the Minority Community to which the institution belongs;

(n) "MUHS" means the Maharashtra University of Health Sciences established under sub-section (1) of Section 3 of the Maharashtra University of Health Sciences Act, 1998 (Mah. X of 1999);

(o) "Qualifying Examination" means examinations on the basis of which a candidate becomes eligible for admission or its equivalent examination thereto;

(p) "the RCI" means the Rehabilitation Council of India Constituted under the Rehabilitation Council of India Act, 1992 ;

(q) "Registration" means the registration of the Post-graduate qualification either with the Maharashtra State Council for Occupational Therapy and Physiotherapy or the Rehabilitation Council of India for BASLP and BPO.

(2) Words and expressions used in these rules but not defined hereinabove shall have the same meanings as respectively assigned to them in the Act.

3. *Invitation of Application Form.*—The Competent Authority shall invite Online or Offline Applications, in the form prescribed by it, from the candidates for participating in Common Entrance Test (CET) for seeking admission to the Courses for which the Common Entrance Test (CET) is required for the respective academic year.

4. *Declaration of Medium, Pattern, Syllabus, Schedule, etc.—* (1) The Competent Authority shall, for the purpose of conducting the declare the following.—

- (a) Medium of CET;
- (b) Pattern of CET;
- (c) Mode of CET;
- (d) Schedule of CET;
- (e) Issue of Hall Ticket;
- (f) Declaration of Result, etc.;

(g) the detailed schedule regarding the Centralized Admission Process (CAP) rounds, admission on the basis of Institutional Quota, admission by Minority Educational Institution, and other matter relating to admission; and

(h) any other matter which is, or may be, necessary for the purposes of conducting the CET.

(2) The Syllabus relating to the CET shall be declared by the Competent Authority with prior approval of the Government of Maharashtra.

5. *Candidature Type.—*

(1) *General Candidature.—*Candidate must be an Indian National. Nationality Certificate issued by District Magistrate or Additional District Magistrate or Chief Metropolitan Magistrate or valid passport or School Leaving Certificate of 12th Std. indicating the nationality of the candidate as "INDIAN" shall constitute the proof of nationality. Persons of Indian Origin (PIO), Non Resident Indian (NRI), Overseas Citizen of India (OCI) are not eligible.

All candidates, who have passed final B.P.Th, B.O.Th, BASLP and BPO, examinations from the College or Institution situated in the State of Maharashtra are eligible to appear for this examination provided he or she has completed prescribed duration of compulsory rotating internship by 31st August.

The candidate who have obtained registration from the respective Council shall be eligible to appear.

(2) *Minority Candidature.—*Candidate belonging to a particular linguistic or religious minority community fulfilling eligibility criteria as per sub-rule (1) of this rule 5 shall be eligible under this Category.

(3) *NRI Candidature.—*The candidate who fulfill the conditions as defined in clause (n) of section 2 of the Act shall be eligible under this category.

6. *Sanctioned Intake Seats for various Courses.—*The Sanctioned Intake for the First Year of the Courses shall be as per the approval given by the appropriate authority which is competent for giving approval to respective courses and affiliation given by the respective affiliating University.

7. *Allocation of Seats.—*The percentage of allocation of seats for various types of candidates through CET for First Year of the Courses shall be specified in the SCHEDULE and in accordance with the policy of the Government for First Year of the Courses.

(1) *General Candidature Seats.—*The Candidates as specified in sub-rules (1) of rule 5, shall be eligible for these seats.

(2) *Minority Quota Seats.—*The Candidates having Candidature mentioned in sub-rule (2) of rule 5 shall be eligible for these seats as specified in the SCHEDULE. These seats shall be filled in accordance with the provisions of sub-section (2) of section 6, of the Act.

(3) *Institutional Quota Seats.*—The Institution can admit Eligible Candidates against the Sanctioned Intake, as per the SCHEDULE, subject to the following conditions, namely :—

(i) The Candidates having Candidature mentioned in sub-rules (1), (2) and (3) of rule 5 shall be eligible for these seats, if applicable.

(ii) The maximum 15% seats may be filled in from the NRI Candidates at the Institution level, subject to the approval by Admission Regulating Authority.

(iii) If the seats reserved for the NRI quota remains vacant, those vacant seats may be filled in by the Institution, from the Eligible General Candidature as given in sub-rules (1) and (2) of rule 5 on the basis of *Inter-se-merit*.

8. *Preparation of Merit List.*—

(1) *Assignment of merit number.*—The Competent Authority shall evaluate the answer sheets of the candidates and declare the result or marks scored by candidate at the CET. The final merit list shall be generated after completing procedure of verification of marks ;

(2) *Method of calculating marks at qualifying examination for deciding eligibility.*—While deciding the eligibility of the Candidates following procedure shall be adopted,—

(a) Marks obtained by the candidate at the PGP-CET/PGO-CET/PGASLP and M.Sc.(P and o)-CET will form the basis of the selection candidate shall be selected on the basis of the merit in common entrance test to the concern course.

(3) *Assignment of Merit Number for various Courses.*— (i) *For admission to First Year PGP-CET/PGO-CET/PGASLP and M.Sc.(P and o)-CET.*—The merit list for the Candidates shall be prepared on the basis of marks or score secured by the Candidate in the CET conducted by the Competent Authority for the purpose of admission to these Courses for the given academic year, the following procedure shall be adopted for deciding *Inter-se-Merit*,—

(a) The candidate with higher aggregate marks (converted into percentage) at First, Second, Third and Fourth year Examinations of B.P.Th. / B.O.Th. taken together and at First, Second and Third year Examinations of B.A.S.L.P./ BPO taken together shall be preferred. If the tie still persists,

(b) The candidate with more marks (converted into percentage) at fourth year B.P.Th./ B.O.Th. or third year B.A.S.L.P. / BPO examination will be preferred. If the tie still persists,

(c) The candidate with more marks (converted into percentage) at third year B.P.Th./ B.O.Th. or second year B.A.S.L.P/ BPO examination will be preferred. If the tie still persists, An older candidate will be preferred over a younger candidate.

(d) While considering aggregate marks for above purpose, grace marks and NSS marks shall not be taken into account.

(4) *Method for calculating NRI merit.*—The merit list for the NRI Candidates stated at sub-rule (3) of rule 5 shall be prepared on the basis of the percentage of marks of Qualifying Examination.

9. *Centralised Admission Process (CAP).*—(1) The Unaided Private Professional Educational Institution shall admit Candidates through the Centralised Admission Process (CAP) as referred in sub-section (3) of section 3 of the Act. The stages of CAP shall be as stated below,—

(a) Display or Publishing of college wise, subject wise and category wise distribution of seats on website ;

(b) Display or Publishing of Time Schedule and Venue for Preference Form filling process on website ;

(c) Display or Publishing Brochure of Preference Form filling and counselling process for admission to Courses ;

(d) Verification of documents and endorsement of eligibility of the successful candidates for the admission process at the document verification centre, Mumbai, followed by filling up of Preference Form by the eligible candidates ;

(e) Display or Publishing of allotment of seats for Round-I of CAP by way of computerised process and joining of the candidates at respective institution as per the allotment within stipulated time;

(f) Display or Publishing of subsequent computerised round(s) if seats remain vacant after completion of CAP Round-I;

(2) Candidate shall be given a chance to retain a seat that has been allotted, by way of status retention form at the end of each CAP round. If a Candidate accepts the offered seat and they do not want to participate in any further rounds of seat allocation then such Candidates shall not be considered in subsequent rounds of admission.

10. CAP allotment stages and process of allotment.— Allotment of seats under CAP shall be made in the following manner,—

(1) General Candidature.—The stages of computerised allotments are as follows.—

Stage-I: For all the Candidates.—

(a) All the Candidates shall be considered for allotment of seats as per their *Inter-se-Merit*.

(b) The Minority category candidate shall be considered for allotment in Open Category seats by virtue of their *Inter-se-Merit* and in Minority Quota seats by virtue of merit in their respective minority community to which the institution belongs.

(c) In Private unaided institutions constitutional reservation is 25 percent of total sanctioned intake as per the Maharashtra Government Notification, Medical Education and Drugs Department, No.MED 2006/1196/CR-204/06/EDU-1(1), dated 24th June 2006. Reservation from Private Unaided Institutions/Colleges is as mentioned below—

(d) Candidates belonging to aforesaid Backward Class categories will be required to submit the Caste Certificate and the Caste/Tribe Validity Certificate at the time of documents verification.

- (i) Scheduled Castes and Schedule Caste converted to Buddhism (S.C.)
- (ii) Scheduled Tribes including those living out-side specified area (S.T.)

GROUP - II

- (i) Vimukta Jati (DT) (A)
- (ii) Nomadic Tribes [NT1(B)]

GROUP - III

- (i) Nomadic Tribes [NT2 (C)]
- (ii) Nomadic Tribes [NT3 (D)]
- (iii) Other Backward Classes (OBC) including SBC

(b) If the seats still remain vacant, then the seats will be filled, from among the candidates of all the categories mentioned above from the all categories combined merit list.

(c) If the seats still remain vacant then the seats will be filled from among the candidates of the common merit list.

Ear-Marking : Reserved category candidate entitled to admission on the basis of merit in an open category seat will have the option of taking admission either against his/her respective category seat or on an open category seat. If he/she opts for the reserved category he/she will be deemed to have been admitted as an open category candidate and not as reserved category candidate. One seat in the college where he/she was eligible for admission against open seat shall be earmarked for a candidate belonging to the respective reserved category. Such earmarked seat will be made available immediately to the successive reserved category candidate from the same category merit.

(2) *For Minority Candidature.*—The stages of computerised allotments are as follows:—

(a) The Minority category candidate shall be considered for allotment in Open category seats by virtue of their *Inter-se-Merit* and in Minority Quota seats by virtue of merit in their respective minority community to which the institution belongs.

(b) For minority seats, *Inter-se-Merit* will be operated at the end of each round if necessary, against the unfilled minority category seats as per merit.

11. *Allotment of seats by CAP Computerised and CAP personal Round.*— All the CAP Rounds shall be conducted by computerised allotment.

(a) If the seat remains vacant due to non-allotment and non-reporting for admission, or any other reason, such seat shall be considered for allotment in subsequent round.

(b) Final personal counselling round shall be conducted for the unfilled seats. The preferences filled by the candidates shall be null and void for this personal counselling round.

All those candidates shall not be eligible for this personal counselling round,—

- (i) who have not filled preference form; or
- (ii) to whom a seat has been allotted in computerised CAP round(s) and not joined;
- (iii) who have filled status retention form; or
- (iv) candidate for whom a seat has been allotted in the previous round(s) and joined the college, but resigned the seat.

12. *General provisions.*— (a) Allotment of the subsequent computerised round(s) shall be on the basis of same preferences submitted by the candidate during preference form filling process.

(b) All the candidates who have filled a preference form and a seat has not been allotted shall be eligible for the subsequent computerised round(s).

(c) All the candidates who have filled a preference form and a seat has been allotted and joined the course and not filled the status retention form shall be eligible for the subsequent computerised round(s).

(d) All the candidates who have filled a preference form and a seat has been allotted and joined the course and filled the Status retention form shall not be eligible for the subsequent computerised round(s).

(e) The allotment list displayed on website shall show the allotment offered to the Candidates. No personal communication or allotment letters in this regard shall be issued to the Candidates;

(f) All the candidates to whom a seat has been allotted on the basis of Merit-cum-preference shall have to compulsorily join the college and course so allotted, within prescribed period by completing the requisite formalities of submitting all relevant original documents and paying prescribed fees in the concern institution. In case he/she does not join the course he or she shall not be eligible for subsequent admission process.

(g) Failure to report in person for seat acceptance shall be considered as if the candidate has rejected the offer.

(h) Allotted Seat shall be cancelled if, at any time, any of the documents or certificates is found to be invalid or fraudulent and/or the Candidate does not meet the eligibility norms.

13. *Admissions in Institutional Quota and vacant seats after CAP.*—The Director or Principal of the institution shall carry out the admissions for these seats in the following manner.—
(a) Admissions shall be made in a transparent manner and strictly as per the *Inter-se-Merit* of the candidate who have applied to the Institution.

(b) Information brochure or prospectus of the Institution which specifies rules of admission should be published well before the commencement of the process of admission. All the information in the brochures should also be displayed on the Institution's website.

(c) Institution shall invite applications by notifying schedule of admission and the number of seats in each course to be filled by the institution, by advertisement in at least two leading newspapers and on the website of the institution.

(d) Aspiring Candidates fulfilling the eligibility criteria as notified by the Government and specified by the appropriate authority, from time to time, shall apply to the Principal or Director of the respective institution for admission at the Institution level.

(e) The institution may give admission to the applicants on the basis of their *Inter-se-Merit* derived from the Merit list declared by the Competent Authority for filling the seats in the Institutional Quota:

Provided that, where the appropriate authority specifies that such admissions shall be based on the basis of CET, in that case the Institutional quota, shall be filled on the basis of *Inter-se-Merit*.

(f) The institution shall prepare and display the *Inter-se-Merit* lists of the Candidates to be filled in at the institution level, in the Institutional Quota and shall publish the same on the website of the institution.

(g) The Minority or Non-Minority institution intending to surrender the Institutional Quota (in part or full) of specified courses to the CAP shall communicate at least one week before the display of seat matrix of each CAP Round and the same shall be allotted as per the rules of CAP.

(h) All the admissions and cancellations shall be communicated to the Competent Authority within the prescribed period given by the Competent Authority, from time to time.

14. *Institution Level Round.*—If the seats remain vacant after all CAP Rounds, the said seats shall be filled in by the institution through Institution Level Round with the prior approval of the Competent Authority. The institute shall invite applications from desirous candidates who are declared eligible in the CET. The admission shall be granted by the institution strictly on the basis of *Inter-se-Merit* of the CET.

15. *Approval of Merit List and the Admitted Candidates List.*— (1) After completion of Admission process, every Unaided Private Professional Educational Institution shall submit the Admission- approval proposal to the Admission Regulating Authority in accordance with the sub-section (5) of section 9 of the Act. (2) The Admission-approval proposal shall include the list of all Candidates admitted which shall have the quota, Candidature type, Qualification Marks, etc., as well as the required documents of the Candidates admitted at institution level.

16. *Refund of fees after cancellation of admission by Institutions.*—(a) Refund of fees by the college after change of college, course or cancellation of admission, (1) On or before such date as may be declared by the competent authority date Rs.1500 (Rs. One Thousand Five Hundred only) to be deducted and rest of the fees which is entitled to be refunded to the candidate, shall be refunded immediately. (2) After such date as may be declared by the competent authority - No refund.

(b) If a candidate expires or becomes unfit to undergo the Courses as decided by notified Medical Board within 3 months from the date of admission, full refund shall be made.

17. *Change of Course or Institution.*—After Cut-off date of admission on mutual basis, change of Course or Institution shall not be permitted.

18. *Conduct and Discipline.*— (a) Failure of the candidate in making full and correct statements in the application form and/or suppression of any information shall lead to disqualification of the candidate, even at later date. Such a candidate shall be debarred from the entire selection process.

(b) It is responsibility of every candidate to submit proper documents. Any attempt to submit documents which are not genuine shall lead to cancellation of the admission of the candidate, forfeiture of the fees, deposits and expulsion of the candidate from the college by the Competent Authority or by his authorised official. The name of such candidate/s shall be deleted from the State Merit List and he/she shall not be eligible for further rounds of the selection process and shall be debarred from the selection process.

(c) If any candidate or Authorised representative or person accompanying is found obstructing the counseling or admission process, or trying to influence in unlawful manner or creating nuisance, the candidate shall be liable for disqualification from the process of selection and appropriate legal action shall be taken. The decision taken by the Competent Authority in this respect shall be final and binding.

(d) Maharashtra University of Health Sciences, Nashik shall take the decision regarding eligibility, enrolment and registration and granting of the term of selected candidates. The selection of a candidate by the Competent Authority at a later date does not place any onus to accord approval for grant of term.

(e) Canvassing directly or indirectly for the allotment of seat would disqualify the candidate for admission. Influencing the staff by unfair means, shall lead to cancellation of allotted seat and such candidate shall also face disqualification for appearance in the subsequent Postgraduate CET.

(f) In case of dispute in the matter of allotment of seat or course or institution or any other matter pertaining to the provisional selection or cancellation of admission, the decision of the Competent Authority shall be final and binding.

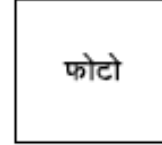
