**ADMISSION NOTICE FOR B.E./B. TECH. FOR ACADEMIC YEAR 2019-20**

This notice is being issued for Online Registration & uploading of documents, Documents Verification and Application Form Confirmation at Setu Suvidha Kendra (SETU) by candidates aspiring for admissions to First Year of Four Year duration Full Time Engineering and Technology program (B.E./ B. Tech.) in the Government, Government Aided, University Managed Institutes, University Managed Departments and Unaided private professional educational institutes for the Academic Year 2019-20 in the Maharashtra State.

**Eligibility Criteria for various types of candidature for Admission:**

(i) The candidate should be an Indian National; (ii) Passed HSC or its equivalent examination with Physics and Mathematics as compulsory subjects along with one of the Chemistry or Biotechnology or Biology or Technical Vocational subjects, and obtained at least 50 % marks (at least 45 % marks, in case of Backward class categories and Persons with Disability candidates belonging to Maharashtra State only) in the above subjects taken together; and The Candidate should have appeared in all the subjects in CET and should obtain non zero score in CET conducted by the Competent Authority; Or (ii) Passed Diploma in Engineering and Technology and obtained at least 50 % marks (at least 45 % marks, in case of Backward class categories and Persons with Disability candidates belonging to Maharashtra State only) ;		The candidate should have passed the HSC or its equivalent examination with Physics and Mathematics as compulsory subjects along with one of the Chemistry or Biotechnology or Biology or Technical Vocational subjects, and obtained at least 50 % marks in the above subjects taken together;

**Online Registration for Admission:-**

**1.1** The candidates should apply online on [www.mahacet.org](http://www.mahacet.org) as per schedule.

**1.2** Candidates who have registered for MHT-CET 2019 are not required to pay any fees for registration for admission. However other candidates who have obtained score which is valid for admission in academic year 2019-20 in JEE (Main) Paper I and have not registered for MHT-CET 2019 are required to pay fees as given below only by **Credit Card/ Debit Card/ Net Banking etc.** through Online mode. Fees paid is non-refundable. (No other mode of payment shall be permitted.)

<ol style="list-style-type: none"> <li><b>All types of candidates</b> aspiring for admission under CAP seats shall register, get Documents Verified &amp; Application Form confirmed at any selected Setu Suvidha Kendra. Such eligible registered candidates shall be considered for CAP Merit and admission through CAP.</li> <li><b>In case of Children of NRI/OCI/PIO, CIWGC, FN Candidates, after registration &amp; confirmation of their application at SETU shall approach directly to the Institute for admission where such quota is granted by the appropriate authority.</b> However, CET Cell may publish the list of such registered &amp; eligible candidates separately on website.</li> <li>Candidate shall carry printed copy of Application Form, Original documents and one set of Xerox copies of the required documents. SETU shall verify all documents from Original and put SETU <b>stamp with date &amp; Signature on Xerox copies</b> and return original and verified documents along with Receipt- cum-Acknowledgement of application form. (Candidate shall submit SETU stamped &amp; verified set of documents to SETU for re-verification after the allotment and then to the Institute at the time of reporting)</li> <li>The candidates aspiring for admission for Institutional Quota, seats remaining vacant after CAP, it is <b>mandatory</b> to get registered, documents verified and confirmation of application at Setu Suvidha Kendras. Such candidates must apply separately to Institutes for admissions to seats other than CAP Seats. Merit of such candidates shall be prepared by the Institute at the institute level.</li> <li>*Facility of Online Registration &amp; Documents verification, confirmation of Application Form for Admission to Seats other than CAP Seats shall be continued till 14<sup>th</sup> August 2019 up to 5.00 PM at SETU. <b>Applications registered, verified &amp; confirmed at SETU after Last Date i.e. 21<sup>st</sup> June 2019 shall be considered only for Non CAP Seats.</b></li> </ol>			

### Important Instructions for candidate:

1. The candidates are required to produce the **documents in original** for verification and Confirmation of Application Form at SETU. It is mandatory on the candidate's part to produce all original documents in support of the claim made by the candidate in the application form. Candidates are advised to keep the necessary documents ready at the time of Documents verification stage as per the notified schedule.
2. If candidates fail to confirm online filled application form at SETU, then such applications will be rejected and name of such candidates will not appear in the merit list(s) prepared for the purpose of Admission for both CAP as well as Non-CAP process.
3. The candidates belonging to SC, VJ/DT, NT (A), NT (B), NT(C), NT (D), OBC, SBC and SEBC categories shall produce "Caste Validity Certificate" and ST category shall submit "Tribe Validity Certificate". All Backward Class candidates excluding SC & ST shall produce **Non Creamy Layer** certificate **valid up to 31<sup>st</sup> March 2020**. EWS candidates shall submit the relevant Certificate. If such candidates fail to produce the Caste/Tribe validity and Non Creamy Layer certificate and Income Certificate (for EWS candidates) at the time of verification at SETU, then such candidates will be treated as GENERAL category candidates for CAP Admissions.
4. Application received after the last date from candidates belonging to J & K Migrant candidates will be summarily rejected and no correspondence will be entertained in this regard. Such Candidates will get the **Receipt-cum-Acknowledgement** through their login after confirmation of application form.
5. Candidates who have registered as a reserved category candidate for MHT-CET 2019 but unable to produce Caste/Tribe certificate for reservation claim during documents verification phase shall have to pay difference of fees of ₹ 200/- at the SETU through online mode only.
6. Once the candidate confirms his/her Option form online through his/her Login for the respective admission rounds, Candidate will not be allowed to change/cancel the option/preference submitted under any circumstances.
7. A Candidate who has been allotted a seat shall download the "Provisional Seat Allotment Letter"
8. The Seat Acceptance Fee shall be Rs.1,000/- for all Candidates. The candidate has to pay the Seat Acceptance Fee during first reporting only. This fee shall be treated as non-refundable processing fee. The Seat Acceptance fees is to be paid at SETU through ONLINE MODE only.
9. Seat will be confirmed by the Setu Suvidha Kendra (SETU) after verification of the original documents and ensuring that the Candidate meets all the eligibility norms. The center in-charge shall issue the Online Receipt of seat acceptance to the candidate. Candidate shall produce the set of copies of uploaded documents verified and stamped by SETU. After verification SETU shall put SETU **stamp with date & Signature on all copies of documents of this set** and return the same set of documents to the candidate along with Receipt -cum-Acknowledgement of application form.

### General Notes:

1. Candidate can avail the IT facilities which is available at Setu Suvidha Kendra (SETU) free of cost for submission, scanning and uploading documents, confirmation of Application form.
2. List of SETU is available on website. All SETU's shall remain open on all days including holidays and Sundays during the schedule between 08.00 a.m. to 08.00 p.m.
3. Eligibility, Rules & regulations for admission shall be made available on the website.
