which is been published on Website www.mahaceta.org for Candidates & Institute Information.

Available Seats

1. All MS & All Indian Seats under purview of Competent Authority except the seats for which the candidates have reported in Round-I, Round II, Additional Cap (Mop Up).
2. All vacant seat shall be available without any seat tag such as Backward (SC, ST, OBC, SBC, VJ/DT, NT-B, NTC, NTD) PWD, DEF, OMS etc. and will be considered as State Level General seats.
3. This Additional Mop UP Round not for OMS (Out of Maharashtra State) Candidates.

Rules of Reporting for Additional Mop Up Round:

- Eligible candidates must report in-person at “**Government College of Art & Design**” in order to secure admission in this round, strictly as per the given schedule on **15 February 2021 from 11.00 AM to 01.00PM** Candidate who report late will not be allowed to participate in this round.
- The candidate should report as per schedule at the **Following Centre of Admission** along with the necessary original document.

- Eligible Candidates who report to the admission centre will be offered admission to available seat as per the inter se merit of candidates.
- **Candidates who secure admission in this round must confirm the admission on the spot by paying non-refundable Seat acceptance charges of Rs.1000/- (in cash) and producing necessary document in original for verification.**
- The Centre of Admission will update the confirmation of the candidate’s admission on mahaceta website through the login immediately.
- If the candidate fails to report to the Institute and pay the Institute fees on 16 February 2021 then the candidate shall lose the claim on the allotted seat as well on the part payment of fee Rs. 1000/- paid by the candidate at the **Centre of Admission.**]
- **Candidate has to register their names personally by visiting at Centre of Admission for Additional Mop Round.(15 Feb 2021 11.00 AM to 01.00 PM)**
- On dated **15 February 2021 (2.30 PM)** the registered candidate’s names will be announced as per *inter se merit*, for available seats. If the announced candidate is not present at that time, the seat will be offered to next merit candidate.
