| Maharashtra State Candidature :Type-A | Candidate Passing SSC & HSC from the State of Maharashtra. | A candidate who is Domicile of Maharashtra. (Candidate should have Domicile Certificate from the State of Maharashtra) OR Candidate should be born in Maharashtra State. (Candidate should have a Birth Certificate mentioning the Place of Birth which is in Maharashtra State. | Your candidature Type is Out Side Maharashtra State Candidature i.e. All India Candidature Type. Explanation: - (a)If candidate has not completed his/her SSC & HSC or Equivalent Qualifying Examination from the State of Maharashtra, then such candidates are not eligible for Maharashtra State Candidature Type-A though candidates are born in Maharashtra OR Candidate Possess the Domicile Certificate from the State of Maharashtra. They should fill the CET Application form as an Out Side Maharashtra State Candidature i.e. All India Candidature Type. (b) If candidate has completed his/her SSC & HSC from the State of Maharashtra but are not born in Maharashtra OR does not have Domicile Certificate from the State of Maharashtra, such candidates are not eligible for Maharashtra State Candidature Type-A. Such candidates should fill the CET Application form as an Out Side Maharashtra State Candidature i.e. All India Candidature Type. (c) If candidate has completed his/her SSC & HSC from the State of Maharashtra, and are not born in Maharashtra but candidate has a Domicile Certificate from the State of Maharashtra then such candidates are eligible for Maharashtra State Candidature type –A. They should fill CET application form as Maharashtra State Candidature Type-A. |

Explanation: (a)If candidate has not completed his/her SSC & HSC or Equivalent Qualifying Examination from the State of Maharashtra, & though candidate's Father or Mother is an employee of the Govt. of India, then such candidate are not eligible for Maharashtra State Candidature Type-C. They should fill the CET Application form as an Out Side Maharashtra State Candidature i.e. All India Candidature Type. (b) If candidate has completed his/her SSC & HSC or Equivalent Qualifying Examination from the State of Maharashtra, & Candidate's Father or Mother is an employee of the Govt. of India OR Government of India Undertaking who is posted and reported to duty in the Maharashtra State before the last date for submitting the Application Form for CET, then such Candidates are eligible for Maharashtra State Candidature Type-C. They should fill the CET Application form as a Maharashtra State Candidature Type-C.</p> |

The children of officers belonging to Indian Administrative Services (IAS) or Indian Police Services (IPS) or Indian Foreign Services (IFS) and children of staff belonging to military and paramilitary forces transferred to Jammu and Kashmir to combat terrorist activities and joined the post on or before the last date for submission of application for admission;</p> <p>OR</p> <p>1.
