In continuation of Notice No. 10 published by this office, this is to inform you that, the National Medical Commission has published Public Notice vide (Ref.No.4) dated 24/12/2020, the Cut-off date of admission in MBBS course for Academic Session 2020-21 is extended till 15/01/2021.

As per letter from MEDD (Ref.No.3) candidates registered for state quota seats by paying Rs.1000/- and who wish to take admission through institutional quota (15%) seats in the Institutional Level Round, can avail it by paying Rs.5000/-.
