Revised Schedule for admission to Medical Postgraduate courses for State Quota seats in Govt/Govt aided and all seats in Private/Minority Colleges of Maharashtra.

Authority had published Revised Schedule for Admission to Medical & Dental Postgraduate courses for State quota seats vide Notice No 4. The said schedule for Postgraduate Medical courses was postponed vide Notice No 7 due to Stay by Hon'ble High Court Bombay .

Now, In view of Stay to the admission process being Vacated by Hon'ble High Court by above referred orders. The Authority has decided to continue admission process for PG 2020 for State Quota seats in Govt/Govt aided and all seats in Private/Minority Colleges of Maharashtra as per the schedule given below

The allotted candidates are being instructed to report the allotted colleges from the date 16.05.2020 to 23.05.2020 by following two modes –

(1) Physical Reporting – (Subject to COVID- 19 restrictions)

- i) The candidate would report to the college physically for taking admission, after paying necessary fees and submission of the original documents at the college and join duties.

OR

(2) Online Reporting –(if not possible physically due to COVID-19 restrictions)

- ii) They can join the allotted college by sending a confirmatory email regarding acceptance of seat and uploading scanned copies of proof of the requisite fees paid online to the Bank Account of college, notified on College portal/website in advance to all concerned.
