- If a candidate cancels his/her admission after this date, he/she has to pay penalty as per rule no.14.4.
- Penalty for Lapse of seat at Government/ Government Aided/Private unaided College (Ayush Course) : Any candidate who resigns a seat after prescribed date i.e. 22/02/2021 from Government/ Government Aided/ Private unaided College (Ayush Course) will have to pay Rs. 3,00,000/- (Rs. Three lakhs only) as penalty.
