- 2. It is mandatory for all aspiring candidates to register the Online Application Form through candidate's login by himself/herself on the web site.
- 3. It should be noted that no documents are required to be submitted at the stage of registration for CET. However, candidates are advised to keep the necessary original documents ready for verification at the time of Document verification stage, during Centralized Admission Process (CAP).
- 4. Application sent by Post/ Courier etc. will be rejected and no communication in this regard will be made.
- 5. MAH-AAC-CET 2020 shall be conducted in Offline & Online mode by Competent Authority. It is mandatory that the candidate must appear for all the papers in Offline & Online sessions of Entrance Examination.
